This announcement is made by the Company pursuant to Rule 13.09(2) of the Listing Rules and the Inside Information Provisions.

The Board wishes to inform the Shareholders and potential investors that based on the preliminary assessment of the unaudited consolidated management accounts of the Group for the six months ended 30 June 2022 and the information currently available to the Board, the Group expects to record a consolidated net loss of HK\$260 million to HK\$290 million in the Relevant Period.

The information contained in this announcement is only based on the preliminary assessment on the unaudited consolidated management accounts of the Group and the information currently available to the Board and is not based on any figures or information audited or reviewed by the independent auditor of the Company and the audit committee of the Company.

Shareholders and potential investors are advised to exercise caution when dealing in the securities of the Company.

This announcement is made by CMBC Capital Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the inside information provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) (“**Inside Information Provisions**”).

The board of directors of the Company (the “**Board**”) wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on the preliminary assessment of the unaudited consolidated management accounts of the Group for the six months ended 30 June 2022 (the “**Relevant Period**”) and the information currently available to the Board, the Group expects to record a consolidated net loss of approximately HK\$260 million to HK\$290 million for the Relevant Period (the corresponding period of last year: consolidated net profit of HK\$201 million).

The Board considers that the above turn from profit to loss was mainly attributable to the impact of a number of unfavorable factors such as the Federal Reserve of the United States tightening its monetary policy, geopolitical tensions and the continuing effects brought by the prevailing pandemic, which led to extreme volatility to capital markets and asset prices and a significant increase in credit risk of certain market entities in the first half of 2022, which caused an increase in the provisions for impairment of expected credit losses on the Group’s bond investments, loans and structured financing and a decrease in carrying fair value of the Group’s investment of equity securities. Other than the above, the Group’s operating position and cash flow remained stable during the Relevant Period.

As at the date of this announcement, the Company is still in the process of preparing the consolidated interim results of the Group for the Relevant Period. The information contained in this announcement is only based on the preliminary assessment on the unaudited consolidated management accounts of the Group and the information currently available to the Board and is not based on any figures or information audited or reviewed by the independent auditor of the Company and the audit committee of the Company. Therefore, the actual results of the Group may be subject to further adjustments and changes. Shareholders and potential investors are advised to read carefully the interim results announcement of the Group for the Relevant Period which is expected to be published in due course.
