**CHANGE OF COMPANY NAME, STOCK SHORT NAME, COMPANY WEBSITE
AND COMPANY LOGO**

Reference is made to the announcements of Silkwave Inc (formerly known as CMMB Vision Holdings Limited) (the “**Company**”) dated 29 March 2022 and 18 May 2022 and the circular of the Company dated 26 April 2022 (the “**Circular**”) in relation to the proposed change of name of the Company (the “**Change of Company Name**”).

Unless the context otherwise requires, capitalised terms used in this announcement shall have the same meanings as those defined in the Circular.

CHANGE OF COMPANY NAME

The Board is pleased to announce that the proposed change of the English name of the Company from “CMMB Vision Holdings Limited” to “Silkwave Inc” and the Chinese name of “中播數據有限公司” to replace its existing Chinese name of “中國移動多媒體廣播控股有限公司” have become effective from 23 June 2022 pursuant to the Certificate of Incorporation on Change of Name issued by the Registrar of Companies in the Cayman Islands. The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 11 July 2022 confirming the registration of the new names of the Company in Hong Kong under Part XVI of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

CHANGE OF STOCK SHORT NAME

The stock short name of the Company for trading in the Shares on the Stock Exchange will be changed from “CMMB VISION” to “SILKWAVE INC” in English and from “中播控股” to “中播數據” in Chinese with effect from 9:00 a.m. on 12 August 2022.

The stock code of the Company on the Stock Exchange remains unchanged as “471”.

EFFECTS OF CHANGE OF COMPANY NAME AND STOCK SHORT NAME

The Change of Company Name and change of stock short name of the Company will not affect any rights of the existing Shareholders. All existing share certificates of the Company in issue bearing the former name of the Company shall continue to be evidence of title to such Shares and valid for trading, settlement, registration and delivery purposes. Accordingly, there will not be any arrangement for the exchange of the existing share certificates for new certificates bearing the new names of the Company. Any issue of share certificates thereafter will be in the new names of the Company.

CHANGE OF COMPANY WEBSITE

The website of the Company has been changed to “www.silkwave.com.hk” to reflect the Change of Company Name.

CHANGE OF COMPANY LOGO

The Board further announces that, with effect from the date of this announcement, the Company has adopted a company logo to reflect the new name of the Company, as shown on the top of this announcement, which will be printed on the relevant corporate documents of the Company, including but not limited to interim and annual reports, announcements, circulars and press releases, and used in its website.
