Accordingly, for the purpose of the unaudited [REDACTED] financial information, the unaudited [REDACTED] adjusted net tangible assets attributable to the owners of the parent will be increased by RMB3,276,406,000, being the carrying amount of the convertible redeemable preferred shares as at 31 December 2021.
