UNAUDITED OPERATING STATISTICS FOR JULY 2022

The board of directors (the “**Board**”) of Yida China Holdings Limited (the “**Company**”) hereby announces certain unaudited operating statistics of the Company and its subsidiaries (the “**Group**”) for July 2022 as follows:

- In July 2022, the Group’s contracted sales amounted to approximately RMB158 million and the Group’s attributable contracted sales was approximately RMB133 million. During the same period, the Group’s gross floor area (“**GFA**”) sold was 13,087 sq.m. and the Group’s attributable GFA sold was 9,516 sq.m.. The Group’s average selling price (the “**ASP**”) was approximately RMB12,100 per sq.m. and the Group’s attributable ASP was approximately RMB14,011 per sq.m..
- For the seven months ended 31 July 2022, the Group’s contracted sales amounted to approximately RMB1,177 million and the Group’s attributable contracted sales was approximately RMB996 million. During the same period, the Group’s GFA sold was 98,388 sq.m. and the Group’s attributable GFA sold was 74,855 sq.m.. The Group’s ASP was approximately RMB11,962 per sq.m. and the Group’s attributable ASP was approximately RMB13,305 per sq.m..

The above-mentioned sales data is unaudited and is based on preliminary internal information of the Group, which may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on annual or semi-annual basis. As such, the above data is provided for investors’ reference only.
