If you post your Reply Form in Hong Kong, you may use the pre-paid mailing label in the Reply Form and need not affix a stamp on the envelope when returning your Reply Form. Otherwise, please affix an appropriate stamp.

If the Company does not receive the duly completed and signed Reply Form or does not receive a response indicating the objection to receiving the Website Version of the Corporate Communications from you on or before 13 September 2022, and until you inform the Company c/o the Hong Kong Branch Share Registrar by reasonable prior notice in writing to the Hong Kong Branch Share Registrar (at the address above) or by e-mail at humanhealth1419-ecom@hk.tricorglobal.com, you will be deemed to have consented to receive the Website Version of all future Corporate Communications instead of printed copies. In that event, the Company will only send notification to you when each Corporate Communication has been made available on the Company's website. The notification will be sent to you by email (if you have provided an email address) or by post (if you have not provided an email address) to you at your address as it appears in the Company's register of members maintained by the Hong Kong Branch Share Registrar.
