- 14. to construct, improve, maintain, work, manage, carry out or control any roads, ways, tramways, branches or sidings, bridges, reservoirs, watercourses, wharves, factories, warehouses, electric works, shops, stores and other works and conveniences that may advance the interests of the company and contribute to, subsidize or otherwise assist or take part in the construction, improvement, maintenance, working, management, carrying out or control thereof;
- 15. to raise and assist in raising money for, and aid by way of bonus, loan, promise, endorsement, guarantee or otherwise, any person and guarantee the performance or fulfilment of any contracts or obligations of any person, and in particular guarantee the payment of the principal of and interest on the debt obligations of any such person;
- 16. to borrow or raise or secure the payment of money in such manner as the company may think fit;
- 17. to draw, make, accept, endorse, discount, execute and issue bills of exchange, promissory notes, bills of lading, warrants and other negotiable or transferable instruments;
- 18. when properly authorized to do so, to sell, lease, exchange or otherwise dispose of the undertaking of the company or any part thereof as an entirety or substantially as an entirety for such consideration as the company thinks fit;
- 19. to sell, improve, manage, develop, exchange, lease, dispose of, turn to account or otherwise deal with the property of the company in the ordinary course of its business;

- 20. to adopt such means of making known the products of the company as may seem expedient, and in particular by advertising, by purchase and exhibition of works of art or interest, by publication of books and periodicals and by granting prizes and rewards and making donations;
- 21. to cause the company to be registered and recognized in any foreign jurisdiction, and designate persons therein according to the laws of that foreign jurisdiction or to represent the company and to accept service for and on behalf of the company and any process or suit;

- (I) dock owners, wharfingers, warehousemen;
- (m) ship chandlers and dealing in rope, canvas oil and ship stores of all kinds;
- (n) all forms of engineering;
- (o) developing, operating, advising or acting as technical consultants to any other enterprise or business;

- (p) farmers, livestock breeders and keepers, graziers, butchers, tanners and processors of and dealers in all kinds of live and dead stock, wool, hides, tallow, grain, vegetables and other produce;
- (q) acquiring by purchase or otherwise and holding as an investment inventions, patents, trade marks, trade names, trade secrets, designs and the like;
- (r) buying, selling, hiring, letting and dealing in conveyances of any sort;
- (s) employing, providing, hiring out and acting as agent for artists, actors, entertainers of all sorts, authors, composers, producers, directors, engineers and experts or specialists of any kind;

## **INTERPRETATION**

The Register including any overseas or local or other branch register of members may, after notice has been given by advertisement in an appointed newspaper and where applicable, any other newspapers in accordance with the requirements of any Stock Exchange or by any means in such manner as may be accepted by the Stock Exchange to that effect, be closed in accordance with the terms equivalent to section 632 of the Companies Ordinance (Cap. 622 of the Laws of Hong Kong as amended from time to time) at such times or for such periods not exceeding in the whole thirty (30) days in each year as the Board may determine and either generally or in respect of any class of shares.
- Business hours (B) The reference to business hours is subject to such reasonable restrictions as the Company in general meeting may impose, but so that not less than two (2) hours in each day is to be allowed for inspection.
  - (C) The branch register of members in Hong Kong shall during normal business hours (subject to such reasonable restrictions as the Board may impose) be open for inspection by a member without charge and any other person on payment of a fee of such

amount not exceeding the maximum amount as may from time to time be permitted under the Companies Act and the rules of the Stock Exchange as the Board may determine for each inspection. Any sum which by the terms of allotment of a share or allotment deemed otherwise is made payable upon allotment or at any fixed time, a call whether on account of the nominal value of the share and/or by way of premium, shall be payable as if it were a call duly made and payable on the date on which by the terms of issue or otherwise is payable, and in case of non-payment all the relevant provisions of these Bye-laws as to payment of interest and expenses, forfeiture and the like, shall apply as if such sum had become payable by virtue of a call duly made and notified. The Board may on the issue of shares differentiate between the allottees or holders as to the amount of calls to be paid and the time of payment.

Evidence of 53. A statutory declaration in writing that the declarant is a forfeiture Director or Secretary, and that a share in the Company has been duly forfeited on a date stated in the declaration, shall be conclusive evidence of the facts therein stated as against all persons claiming to be entitled to the share. The Company may receive the consideration, if any, given for the share on any sale or disposition thereof and the Board may authorise some person to execute a transfer of the share in favour of the person to whom the share is sold or disposed of and the latter person shall thereupon be registered as the holder of the share, and shall not be bound to see to the application of the purchase money, if any, nor shall his title to the share be affected by any irregularity or invalidity in the proceedings in reference to the forfeiture, sale or disposal of the share.

Notice after forfeiture 54. When any share shall have been forfeited, notice of the resolution shall be given to the member whose name it stood immediately prior to the forfeiture but no forfeiture shall be invalidated by any omission or neglect to give such notice. An entry of the forfeiture, with the date thereof, shall forthwith be made in the Register.

Power to redeem forfeited shares	55.	Notwithstanding any such forfeiture as aforesaid the Board may at any time, before any shares so forfeited shall have been sold, re-allotted, or otherwise disposed of, permit the share aforesaid to be redeemed upon the terms of payment of all calls or instalments of a call, interest due upon and expenses incurred in respect of the share, and upon such further terms (if any) as it thinks fit.

The Board may from time to time, if it thinks fit, fix the minimum amount of stock transferable and restrict or forbid the transfer of fractions of that minimum, but so that such minimum shall not exceed the nominal amount of the shares from which the stock arose. No warrants to bearer shall be issued in respect of any stock;
Rights of stockholders		(3) The holders of stock shall, according to the amount of the stock held by them, have the same rights, privileges and advantages as regards dividends, participation in assets on a winding-up, voting at general meetings of the Company and other matters, as if they held the shares from which the stock arose, but no such privilege or advantage (except participation in the dividends and profits of the Company) shall be conferred by an amount of stock which would not, if existing in shares, have conferred such privilege or advantage;
Interpretation		<ul><li>(4) Such of the provisions of these presents as are applicable to paid up shares shall apply to stock, and the words "share" and "shareholder" therein shall include "stock" and "stockholder".</li><li>UNTRACEABLE MEMBERS</li></ul>
Untraceable members	60.(A)	The Board may by resolution at any time sell any shares of a member who is untraceable at a price determined as provided in paragraph (B) provided that all the conditions specified in paragraph (D) are satisfied.
	(B)	The price at which any shares may be sold pursuant to the provisions of paragraph (A) of this Bye-law shall be the best price reasonably obtainable at the time of the sale.

- (C) To give effect to any such sale, the Board may, notwithstanding other provisions of these Bye-laws, authorise some person to execute on behalf of the untraceable member a transfer in favour of the purchaser and upon receipt by the Company of the purchase money the Company shall cause the name of the purchaser to be entered in the Register as the holder of the shares but so that notwithstanding the provisions of Bye-law 39(2) the Board shall not be bound to require the production or deposit of any share certificate. After the purchaser's name has been entered in the Register in the purported exercise of the power conferred by this Bye-law, the validity of the proceedings shall not be questioned by any person. The purchase money shall constitute a debt of the Company but no trust shall be created in respect of such debt. Such money shall until payment over to the untraceable member be available to the Company for its own use free of interest and without any liability to account for any profit arising therefrom.
- (D) The power of sale provided in paragraph (A) shall only be exercisable if:
  - during the period of twelve (12) years immediately preceding the date of the resolution of the Board referred to in paragraph (A) of this Bye-law at least three (3) dividends whether interim or final have been paid by the Company and no dividend during that period has been claimed by the member;
  - (2) the Company has at or after the expiration of the said period of twelve (12) years by advertisement published in the Newspapers given notice of its intention to sell the shares of such member;
  - (3) the Company has not during the further period of three (3) months after the date of the advertisement and prior to the exercise of the power of sale received any communication from the member or person entitled by transmission; and
  - (4) the Company has notified the Stock Exchange of its intention of such sale.

(E) For the purposes of this Bye-law, a statutory declaration by the Secretary in relation to any member to the effect that the foregoing provisions of this paragraph (D) have been satisfied shall be conclusive and binding on the Company and the member concerned and all persons claiming through or under him.

  - (C) Except so far as otherwise provided by the conditions of issue, or by these Bye-laws, any capital raised by the creation of new shares shall be treated as if it formed part of the original capital of the Company, and such shares shall be subject to the provisions contained in these Bye-laws with reference to the payment of calls and instalments, transfer and transmission, forfeiture, lien, cancellation, surrender, voting and otherwise.
  - 62.(A) The Company may from time to time by Ordinary Resolution:
    - consolidate or divide all or any part of its share capital into shares of a larger or smaller amount than its existing shares and on any consolidation of fully paid share into shares of a larger amount, the Board may settle any difficulty which

The Board may raise or secure the payment or repayment of such sum or sums in such manner and upon such terms and conditions in all respects as it thinks fit and, in particular, subject to the Companies Act, by the issue of debentures, debenture stock, bonds or other securities of the Company, whether outright or as collateral security for any debt, liability or obligation of the Company or of any third party.
Assignment of debentures	65.	Debentures, debenture stock, bonds and other securities may be made assignable free from any equities between the Company and the person to whom the same may be issued.
Special privileges	66.	Any debentures, debenture stock, bonds or other securities may be issued at a discount (other than shares), premium or otherwise and with any special privileges as to redemption, surrender, drawings, allotment of shares, attending and voting at general meetings of the Company, appointment of Directors and otherwise.

Register of charges to be kept	67.(A)	The Board shall cause a proper register to be kept, in accordance
		with the provisions of the Companies Act, of all mortgages and

- Mortgage of uncalled capital 68. Where any uncalled capital of the Company is charged, all persons taking any subsequent charges thereon shall take the same subject to such prior charge, and shall not be entitled, by notice to the members or otherwise, to obtain priority over such prior charge.

# GENERAL MEETINGS

- When annual general meeting to be held 69.(A) The Company shall in each financial year hold a general meeting as its annual general meeting, shall specify the meeting as such in the notice calling it, and such annual general meeting must be held within six (6) months after the end of the Company's financial year (unless a longer period would not infringe the rules of the Stock Exchange, if any).
- Written resolutions Save where a general meeting is required by the (B) (i) of members Companies Act, anything which may be done by Ordinary Resolution or Special Resolution in general meeting may be done by resolution in writing, signed by the required majority of the shareholders or any class thereof or their proxies, or in the case of a shareholder that is a corporation (whether or not a company within the meaning of the Companies Act) by its representative on behalf of such shareholder, being the required majority of the shareholders of the Company or any class thereof who at the date of the notice of the resolution in writing would be entitled to attend a meeting and vote on the resolution. Such resolution in writing may be signed in as many counterparts as may be necessary.

- (ii) Notice of any resolution in writing to be made under this Bye-law shall be given, and a copy of the resolution shall be circulated, in the same manner as that required for a notice of a general meeting of the Company at which the resolution could have been considered, except that the length of the period of notice shall not apply.
- (iii) The accidental omission to give notice of, or to circulate a copy of, a resolution in writing to be made under this Byelaw, or the non-receipt of such notice or copy by, any person entitled to receive such notice or copy shall not invalidate the passing of the resolution.
- (iv) For the purposes of this Bye-law, the date of the resolution in writing is the date when the resolution is signed by, or on behalf of, the shareholder who establishes the majority of votes required for the passing of the resolution and any reference in any enactment to the date of passing of a resolution is, in relation to a resolution in writing made in accordance with this Bye-law, a reference to such date.
- (v) A resolution in writing made in accordance with this Byelaw is as valid as if it had been passed by the Company in general meeting or, if applicable, by a meeting of the relevant class of shareholders of the Company, as the case may be. A resolution in writing made in accordance with this Bye-law shall constitute minutes for the purposes of the Companies Acts and these Bye-laws.
- Special general<br/>meeting70.All general meetings other than annual general meetings shall<br/>be called special general meetings. All general meetings<br/>(including an annual general meeting, any adjourned meeting or<br/>postponed meeting) may be held as a physical meeting in any<br/>part of the world at one or more locations as provided in Bye-<br/>law 78.(A), as a hybrid meeting or as an electronic meeting, as<br/>may be determined by the Board in its absolute discretion.
- Convening of special general meeting 71. The Board may, whenever it thinks fit, convene a special general meeting and one or more members (including a recognized clearing house (or its nominee)) holding as at the date of deposit of the requisition, in aggregate at least one-tenth of the voting rights, on a one vote per share basis, in the share capital of the Company shall at all times have the right, by written requisition to the Board or the Secretary of the Company, to convene a special general meeting and add resolutions to the meeting agenda; and such meeting shall be

held within two (2) months after the deposit of such requisitions. If within twenty-one (21) days of such deposit the Board fails to proceed to convene such meeting the requisitionists themselves may do so in accordance with the provisions of Section 74(3) of the Companies Act.

- Notice of meeting 72.(A) An annual general meeting shall be called by at least twentyone (21) days' notice in writing and a meeting other than an annual general meeting shall be called by at least fourteen (14) days' notice in writing. The notice shall specify the place, the day and the hour of meeting and shall contain particulars of the resolutions to be considered at the meeting; in the case of special business (as referred to in Bye-law 74), the general nature of that business shall be given in the manner hereinafter mentioned or in such other manner, if any, as may be prescribed by the Company in general meeting to such persons as are, under these Bye-laws, entitled to receive such notices from the Company. Every notice of an annual general meeting shall specify the meeting as such and every notice of a meeting convened for passing a Special Resolution shall state the intention to propose such resolution as a Special Resolution.
  - (B) Subject to the requirement under the rules of the Stock Exchange, the notice shall be exclusive of the day on which it is served or deemed to be served and of the day for which it is given, and shall specify the time, place, and agenda of the meeting, particulars of the resolutions and the general nature of the business to be considered at the meeting. The notice convening an annual general meeting shall specify the meeting as such, and the notice convening a meeting to pass a special resolution shall specify the intention to propose the resolution as a special resolution. Notice of every general meeting shall be given to the Auditors and to all members other than such as, under the provisions hereof or the terms of issue of the shares they hold, are not entitled to receive such notice from the Company. Subject to the provisions of the Companies Act and the rules of the Stock Exchange, a meeting of the Company notwithstanding that it is called by shorter notice than that specified in this Bye-law shall be deemed to have been duly called if it is so agreed:

- (1) in the case of the annual general meeting, by all the members entitled to attend and vote thereat; and
- (2) in the case of any other meeting, by a majority in number of the members having a right to attend and vote at the meeting, being a majority together representing not less than 95 per cent. in nominal value of the shares giving a right to attend and vote at such meeting.
- (C) The notice shall specify (a) the time and date of the meeting, (b) save for an electronic meeting, the place of the meeting and if there is more than one meeting location as determined by the Board pursuant to Bye-law 78.(A), the principal place of the meeting (the "Principal Meeting Place") and the other place(s) of the meeting, (c) if the general meeting is to be a hybrid meeting or an electronic meeting, the notice shall include a statement to that effect and with details of the electronic facilities for attendance and participation by electronic means at the meeting (which electronic platform may vary from time to time and from meeting to meeting as the Board, in its sole discretion, may see fit) or where such details will be made available by the Company prior to the meeting, and (d) particulars of resolutions to be considered at the meeting. The notice convening an annual general meeting shall specify the meeting as such. Notice of every general meeting shall be given to all members other than to such members as, under the provisions of these Bye-laws or the terms of issue of the shares they hold, are not entitled to receive such notices from the Company, to all persons entitled to a share in consequence of the death or bankruptcy or winding-up of a member and to each of the Directors and the Auditors.
- Omission to notice 73.(A) The accidental omission to give any such notice to, or the nonreceipt of any such notice by, any person entitled to receive notice shall not invalidate any resolution passed or any proceedings at any such meeting.
  - (B) In case where instruments of proxy are sent out with notices, the accidental omission to send such instrument of proxy to, or the non-receipt of such instrument of proxy by, any person entitled to receive notice shall not invalidate any resolution passed at or any proceedings at any such meeting.

## PROCEEDINGS AT GENERAL MEETINGS

Special business 74. All business shall be deemed special that is transacted at a

Business of annual general meeting		special general meeting and also all business that is transacted at an annual general meeting with the exception of the declaration and sanctioning of dividends, making a call in accordance with the provisions of these Bye-laws, the reading, consideration and adoption of the profit and loss account, the balance sheet and group accounts (if any) of the Company and the reports of the Directors and Auditors and other documents required to be annexed to the balance sheet, the election or re- election of Directors, the appointment or re-appointment of the Auditors and other officers in the place of those retiring, the fixing of the remuneration of the Auditors and the fixing of remuneration or extra remuneration of the Directors.
Methods of attending meetings of shareholders	(A)	A meeting of the shareholders or any class thereof may be held by means of such telephone, electronic or other communication facilities (including, without limiting the generality of the foregoing, by telephone, or by video conferencing) as permit all persons participating in the meeting to communicate with each other simultaneously and instantaneously, and participation in such a meeting shall constitute presence in person at such meeting.
Quorum	75.	Save as otherwise provided in these Bye-laws, for all purposes the quorum for a general meeting shall be two (2) members present in person or by proxy or, for quorum purposes only, two persons appointed by the clearing house as authorized representative or proxy shall form a quorum for all purposes. No business shall be transacted at any general meeting unless the requisite quorum shall be present at the commencement of the meeting.
When if quorum not present meeting to be dissolved and when to be adjourned	76.	If, within half an hour from the time appointed for the meeting, a quorum is not present, the meeting, if convened by or upon the requisition of members, shall be dissolved, but in any other case it shall stand adjourned to the same day in the next week (or if that day be a public holiday in the Relevant Territory, then to the next business day following such public holiday), at the same time and place(s) or to such other day and at such time and (where applicable) such place(s) and in such form and manner referred to in Bye-law 70 as shall be determined by the Board and no notice of such adjournment need be given.
Chairman of general meeting	77.	One of the co-chairmen of the Company appointed under the provision of Bye-law 122.(A) or the chairman, if one is appointed, if there is more than one chairman, any one of them as may be agreed amongst themselves or failing such agreement, any one of them elected by all the Directors present,

shall preside as Chairman at a general meeting. If at any general meeting no chairman is present within fifteen (15) minutes after the time appointed for holding such meeting, or is willing to act as Chairman, the Directors present shall choose one of their number to act as the Chairman of such meeting, or if only one Director is present he shall preside as Chairman if he is willing to act. If no Director is present at such general meeting, or if each of the Directors present declines to take the chair, then the members present in person or by proxy and entitled to vote shall choose one of their number to act as Chairman of that Meeting.

77.(A) The Chairman of a general meeting (be it a physical meeting, a hybrid meeting or an electronic meeting) may attend, preside as Chairman at, and conduct proceedings of, such meeting by means of electronic facilities.

Power to adjourn 78. Subject to Bye-law 78.(C), the Chairman may, with the consent general meeting, of any general meeting at which a quorum is present, and shall, business of adjourned meeting if so directed by the meeting, adjourn any meeting from time to time (or indefinitely) and/or from place to place(s) and/or from one form to another (a physical meeting, a hybrid meeting or an electronic meeting) as the meeting shall determine, but no business shall be transacted at any adjourned meeting other than the business which might lawfully have been transacted at the meeting had the adjournment not taken place. When a meeting is adjourned sine die, the time and place for the adjourned meeting shall be fixed by the Board. Whenever a meeting is adjourned for thirty (30) days or more or sine die, at least seven (7) days' notice, specifying the place, the day and the hour of the adjourned meeting shall be given in the same manner as in the case of an original meeting but it shall not be necessary to specify in such notice the nature of the business to be transacted at the adjourned meeting. Save as aforesaid, no member shall be entitled to any notice of an adjournment or of the business to be transacted at any adjourned meeting. No business shall be transacted at any adjourned meeting other than the business which might have been transacted at the meeting from which the adjournment took place.

(1) The Board may, at its absolute discretion, arrange for persons entitled to attend a general meeting to do so by simultaneous attendance and participation by means of electronic facilities at such location or locations ("Meeting Location(s)") determined by the Board at its absolute discretion. Any member or any proxy attending and

participating in such way or any member participating in an electronic meeting or a hybrid meeting by means of electronic facilities is deemed to be present at and shall be counted in the quorum of the meeting.

- (2) All general meetings are subject to the following and, where appropriate, all references to a "member" or "members" in this sub-paragraph (2) shall include a proxy or proxies respectively:
  - (a) where a member is attending a Meeting Location and/or in the case of a hybrid meeting, the meeting shall be treated as having commenced if it has commenced at the Principal Meeting Place;
  - (b) members present in person or by proxy at a Meeting Location and/or members participating in an electronic meeting or a hybrid meeting by means of electronic facilities shall be counted in the quorum for and entitled to vote at the meeting in question, and that meeting shall be duly constituted and its proceedings valid provided that the Chairman of the meeting is satisfied that adequate electronic facilities are available throughout the meeting to ensure that members at all Meeting Locations and members participating in an electronic facilities are able to participate in the business for which the meeting has been convened;
  - (c) where members attend a meeting by being present at one of the Meeting Locations and/or where members participating in an electronic meeting or a hybrid meeting by means of electronic facilities, a failure (for reason) of the electronic facilities anv or communication equipment, or any other failure in the arrangements for enabling those in a Meeting Location other than the Principal Meeting Place to participate in the business for which the meeting has been convened or in the case of an electronic meeting or a hybrid meeting, the inability of one or more members or proxies to access, or continue to access, the electronic facilities despite adequate electronic facilities having been made available by the Company, shall not affect the validity of the meeting or the resolutions passed, or any business conducted there or any action taken

pursuant to such business provided that there is a quorum present throughout the meeting; and

- (d) if any of the Meeting Locations is outside the jurisdiction of the Principal Meeting Place and/or in the case of a hybrid meeting, unless otherwise stated in the notice, the provisions of these Bye-laws concerning the service and giving of notice for the meeting, and the time for lodging proxies, shall apply by reference to the Principal Meeting Place; and in the case of an electronic meeting, the time for lodging proxies shall be as stated in the notice for the meeting.
- 78.(B) The Board and, at any general meeting, the Chairman of the meeting may from time to time make arrangements for managing attendance and/or participation and/or voting at the Principal Meeting Place, any Meeting Location(s) and/or participation in an electronic meeting or a hybrid meeting by means of electronic facilities (whether involving the issue of tickets or some other means of identification, passcode, seat reservation, electronic voting or otherwise) as it shall in its absolute discretion consider appropriate, and may from time to time change any such arrangements, provided that a member who, pursuant to such arrangements, is not entitled to attend, in person or by proxy, at any Meeting Location shall be entitled so to attend at one of the other Meeting Locations; and the entitlement of any member so to attend the meeting or adjourned meeting or postponed meeting at such Meeting Location or Meeting Locations shall be subject to any such arrangement as may be for the time being in force and by the notice of meeting or adjourned meeting or postponed meeting stated to apply to the meeting.
- 78.(C) If it appears to the Chairman of the general meeting that:
  - (a) the electronic facilities at the Principal Meeting Place or at such other Meeting Location(s) at which the meeting may be attended have become inadequate for the purposes referred to in Bye-law 78.(A)(1) or are otherwise not sufficient to allow the meeting to be conducted substantially in accordance with the provisions set out in the notice of the meeting; or
  - (b) in the case of an electronic meeting or a hybrid meeting, electronic facilities being made available by the Company have become inadequate; or

- (c) it is not possible to ascertain the view of those present or to give all persons entitled to do so a reasonable opportunity to communicate and/or vote at the meeting; or
- (d) there is violence or the threat of violence, unruly behaviour or other disruption occurring at the meeting or it is not possible to secure the proper and orderly conduct of the meeting;

then, without prejudice to any other power which the Chairman of the meeting may have under these Bye-laws or at common law, the Chairman may, at his/her absolute discretion, without the consent of the meeting, and before or after the meeting has started and irrespective of whether a quorum is present, interrupt or adjourn the meeting (including adjournment for indefinite period). All business conducted at the meeting up to the time of such adjournment shall be valid.

- 78.(D) The Board and, at any general meeting, the Chairman of the meeting may make any arrangement and impose any requirement or restriction the Board or the Chairman of the meeting, as the case may be, considers appropriate to ensure the security and orderly conduct of a meeting (including, without limitation, requirements for evidence of identity to be produced by those attending the meeting, the searching of their personal property and the restriction of items that may be taken into the meeting place, determining the number and frequency of and the time allowed for questions that may be raised at a meeting). Members shall also comply with all requirements or restrictions imposed by the owner of the premises at which the meeting is held. Any decision made under this Bye-law shall be final and conclusive and a person who refuses to comply with any such arrangements, requirements or restrictions may be refused entry to the meeting or ejected (physically or electronically) from the meeting.
- 78.(E) If, after the sending of notice of a general meeting but before the meeting is held, or after the adjournment of a meeting but before the adjourned meeting or postponed meeting is held (whether or not notice of the adjourned meeting or postponed meeting is required), the Directors, in their absolute discretion, consider that it is inappropriate, impracticable, unreasonable or undesirable for any reason to hold the general meeting on the date or at the time or place and/or by means of electronic facilities specified in the notice calling the meeting, they may

change or postpone the meeting to another date, time and/or place and/or change the electronic facilities and/or change the form of the meeting (a physical meeting, an electronic meeting or a hybrid meeting) without approval from the members. Without prejudice to the generality of the foregoing, the Directors shall have the power to provide in every notice calling a general meeting the circumstances in which a postponement of the relevant general meeting may occur automatically without further notice, including without limitation where a tropical cyclone warning signal no. 8 or above, black rainstorm warning or other similar event is in force at any time on the day of the meeting. This Bye-law shall be subject to the following:

- (a) when a meeting is so postponed, the Company shall endeavour to post a notice of such postponement on the Company's website as soon as practicable (provided that failure to post such a notice shall not affect the automatic postponement of such meeting);
- (b) when only the form of the meeting or electronic facilities specified in the notice are changed, the Board shall notify the members of details of such change in such manner as the Board may determine;
- (c) when a meeting is postponed or changed in accordance with this Bye-law, subject to and without prejudice to Bye-law 78, unless already specified in the original notice of the meeting, the Board shall fix the date, time, place (if applicable) and electronic facilities (if applicable) for the postponed or changed meeting and shall notify the members of such details in such manner as the Board may determine; further all proxy forms shall be valid (unless revoked or replaced by a new proxy) if they are received as required by these Bye-laws not less than forty-eight (48) hours before the time of the postponed or changed meeting; and
- (d) notice of the business to be transacted at the postponed or changed meeting shall not be required, nor shall any accompanying documents be required to be recirculated, provided that the business to be transacted at the postponed or changed meeting is the same as that set out in the original notice of general meeting circulated to the members.
- 78.(F) All persons seeking to attend and participate in an electronic meeting or a hybrid meeting shall be responsible for maintaining adequate facilities to enable them to do so. Subject to Bye-law 78.(C), any inability of a person or persons to attend

or participate in a general meeting by way of electronic facilities shall not invalidate the proceedings of and/or resolutions passed at that meeting.

- 78.(G) Without prejudice to other provisions in Bye-laws 78.(A) to 78.(F), a physical meeting may also be held by means of such telephone, electronic or other communication facilities as permit all persons participating in the meeting to communicate with each other simultaneously and instantaneously, and participation in such a meeting shall constitute presence in person at such meeting.
- 78.(H) Without prejudice to Bye-laws 78.(A) to 78.(G) and subject to the Statutes and the rules of the Stock Exchange and any other applicable laws, the Board may resolve to enable persons entitled to attend an electronic meeting to do so by simultaneous attendance by means of electronic facilities with no member necessarily in physical attendance and without any particular Meeting Location being designated, each member or its proxy shall be counted in the quorum for, and entitled to vote at, the electronic meeting in question, and that general meeting shall be duly constituted and its proceedings valid if the Chairman of the electronic meeting is satisfied that adequate facilities are available throughout the electronic meeting to ensure that members attending the electronic meeting who are not present together at the same place may, by means of electronic facilities, attend and speak or communicate and vote at it.

#### VOTES OF MEMBERS

(1) Subject to any special rights or restrictions as to voting for 85.(A) the time being attached to any shares by or in accordance with these Bye-laws, at any general meeting on a poll every member present in person or by proxy shall have one vote for every fully paid-up share of which he is the holder but so that no amount paid up or credited as paid up on a share in advance of calls or instalments is treated for the foregoing purposes as paid up on the share. A resolution put to the vote of a meeting shall be decided by way of a poll save that in the case of a physical meeting, the Chairman of the meeting may in good faith, allow a resolution which relates purely to a procedural or administrative matter to be voted on by a show of hands in which case every member present in person or by proxy(ies) shall have one vote provided that where more than one proxy is appointed by a member which is a clearing house (or its nominee(s)), each such proxy shall have one vote on a show of hands. For purposes of this Byelaw, procedural and administrative matters are those that (i) are not on the agenda of the general meeting or in any supplementary circular that may be issued by the Company to its members; and (ii) relate to the Chairman's duties to maintain the orderly conduct of the meeting and/or allow the business of the meeting to be properly and effectively dealt with, whilst allowing all members a reasonable opportunity to express their views. Votes (whether on a show of hands or by way of poll) may be cast by such means, electronic or otherwise, as the Directors or the Chairman of the meeting may determine.

- (2) In the case of a physical meeting where a show of hands is allowed, before or on the declaration of the result of the show of hands, a poll may be demanded:
  - (a) by the Chairman of the meeting; or
  - (b) by at least three members present in person or by proxy(or in the case of a member being a corporation by its duly authorised representative or proxy) for the time being entitled to vote at the meeting; or

- (c) by a member or members present in person or by proxy (or in the case of a member being a corporation by its duly authorised representative or proxy) and representing not less than one-tenth of the total voting rights of all members having the right to vote at the meeting; or
- (d) by a member or members present in person or by proxy (or in the case of a member being a corporation by its duly authorised representative or proxy) and holding shares in the Company conferring a right to vote at the meeting being shares on which an aggregate sum has been paid up equal to not less than one-tenth of the total sum paid up on all shares conferring that right.

A demand by a person as proxy for a member shall be deemed to be the same as a demand by the member.

- (B) All members (including a shareholder which is a clearing house (or its nominee(s))) shall have the right to (a) speak at a general meeting; and (b) vote at a general meeting except where a member is required, by the rules of the Stock Exchange, to abstain from voting to approve the matter under consideration. Where any member is, under the rules of the Stock Exchange, required to abstain from voting on any particular resolution or restricted to voting only for or only against any particular resolution, any votes cast by or on behalf of such member in contravention of such requirement or restriction shall not be counted.
- Joint holders 86. Where there are joint registered holders of any share, any one of such persons may vote at any meeting, adjourned meeting or postponed meeting, either personally or by proxy, in respect of such shares as if he were solely entitled thereto; but if more than one of such joint holders be present at any meeting personally or by proxy, that one of the said persons so present whose name stands first on the register in respect of such share shall alone be entitled to vote in respect thereof. Several executors or administrators of a deceased member in whose name any share stands shall for the purposes of this Bye-law be deemed joint holders thereof.
- Votes of member of unsound mind 87. A member of unsound mind or in respect of whom an order has been made by any court (whether in the Relevant Territory or elsewhere) having jurisdiction in mental health, may vote, by his committee, receiver, curator bonis or other person in the

nature of a committee, receiver or curator bonis appointed by that court, and any such committee, receiver or curator bonis or other person may cast his vote personally or by proxy provided that such evidence as the Board may require of the authority of the person claiming to vote shall have been deposited at the Head Office not less than forty-eight (48) hours before the time for holding the meeting, adjourned meeting or postponed meeting at which such person claims to vote.

- Qualification for voting 88.(A) Save as expressly provided in these Bye-laws, no person other than a member duly registered and who shall have paid in full for the time being any sum due from him to the Company in respect of his shares shall be entitled to be present or to vote (save as proxy for another member) either personally or by proxy, or to be reckoned in a quorum, at any general meeting.
  - (B) No objection shall be raised to the qualification of any voter except at the meeting, adjourned meeting, or postponed meeting at which the vote objected to is given or tendered, and every vote not disallowed at such meeting shall be valid for all purposes. Any such objection made in due time shall be referred to the Chairman, whose decision shall be final and conclusive.

Proxies 89. Any member (including a clearing house), whether an individual or a corporation, entitled to attend and vote at a meeting of the Company or a meeting of the holders of any class of shares in the Company shall be entitled to appoint another person (being a natural person) as his proxy or representative (if such member is a corporation) to attend and vote in place of such member. Votes may be given either personally or by proxy. A member which is a corporation may execute a form of proxy under the hand of a duly authorised officer. A member who is the holder of two or more shares may appoint more than one proxy or representative to attend and vote on the same occasion provided that, if more than one proxy or representative is so appointed, the appointment shall specify the number and class of shares in respect of which each such proxy is so appointed. A proxy or representative need not be a member. In addition, a proxy/proxies or a representative/representatives representing either an individual member or a member which is a corporation, shall be entitled to exercise the same powers on behalf of the member which he or they represent as such member could exercise, including the right to vote individually on a show of hands, as if it were a natural person member present in person at any general meeting.

The instrument appointing a proxy shall be in writing and if the Board in its absolute discretion determines, may be contained in an electronic communication, and (i) if in writing but not contained in an electronic communication, under the hand of the appointor or of his attorney duly authorised in writing, or if the appointor is a corporation, either under its common seal or under the hand of an officer or attorney duly authorised; or (ii) in the case of an appointment contained in an electronic communication, submitted by or on behalf of the appointer, subject to such terms and conditions and authenticated in such manner as the Board may in its absolute discretion determine. In the case of an instrument of proxy purporting to be signed on behalf of a corporation by an officer thereof it shall be assumed, unless the contrary is proved, that such officer was duly authorised to sign such instrument of proxy on behalf of the corporation without further evidence of the fact. The Board may, nevertheless, require such evidence as it shall deem necessary as to the due execution of the instrument of proxy and the due authorisation of the same.

(1) The Company may, at its absolute discretion, provide an 91. electronic address for the receipt of any document or information relating to proxies for a general meeting (including any instrument of proxy or invitation to appoint a proxy, any document necessary to show the validity of, or otherwise relating to, an appointment of proxy (whether or not required under these Bye-laws) and notice of termination of the authority of a proxy). If such an electronic address or electronic means of submission is provided, the Company shall be deemed to have agreed that any such document or information (relating to proxies as aforesaid) may be sent by electronic means to that address, subject as hereafter provided and subject to any other limitations or conditions specified by the Company when providing the address or electronic means of submission. Without limitation, the Company may from time to time determine that any such electronic address or electronic means of submission may be used generally for such matters or specifically for particular meetings or purposes and, if so, the Company may provide different electronic addresses or electronic means of submission for different purposes. The Company may also impose any conditions on the transmission of and its receipt of such electronic communications including, for the avoidance of doubt, imposing any security or encryption arrangements as may be specified by the Company. If any document or information required to be sent to the Company under this

Bye-law is sent to the Company by electronic means, such document or information is not treated as validly delivered to or deposited with the Company if the same is not received by the Company at its designated electronic address provided in accordance with this Bye-law or if no electronic address or electronic means of submission is so designated by the Company for the receipt of such document or information.

- (2) The instrument appointing a proxy and the power of attorney or other authority, if any, under which it is signed or a notarially certified copy of that power or authority together with such evidence as the Board may require under Bye-law 90 shall be deposited at the Head Office or at such other place as is specified for that purpose in the notice convening the meeting or in the instrument of proxy issued by the Company in relation to the meeting, or if the Company has provided an electronic address or electronic means of submission in accordance with the preceding paragraph, shall be received at the electronic address or electronic means of submission specified, not less than forty-eight (48) hours before the time appointed for holding the meeting, adjourned meeting or postponed meeting (as the case may be) at which the person named in such instrument proposes to vote; and in default the instrument of proxy shall not be treated as valid except with the consent of the Chairman. No instrument appointing a proxy shall be valid after the expiration of twelve (12) months from the date of its execution, except at an adjourned meeting or postponed meeting in a case where the meeting was originally held within twelve (12) months from such date. Delivery of an instrument appointing a proxy shall not preclude a member from attending and voting in person at the meeting concerned and, in such event, the instrument appointing a proxy shall deemed to be revoked.
- Form of proxy 92. Every instrument of proxy, whether for a specified meeting or otherwise, shall be in such form as the Board may from time to time approve (provided that this shall not preclude the use of a two-way form).
- Authority under 93. The instrument of proxy, which need not be witnessed, appointing proxy appointing a proxy to vote at a general meeting shall:
  - (1) be deemed to confer authority to demand or join in demanding a poll and to vote on any resolution (or amendment thereto) put to the meeting for which it is given as the proxy thinks fit provided that any form issued to a

member for use by him for appointing a proxy to attend and vote at a special general meeting or at an annual general meeting at which any business is to be transacted shall be such as to enable the member, all resolutions put to the members at electronic meetings shall be voted on by a poll, according to his intention, to instruct the proxy to vote in favour of or against (or, in default of instructions, to exercise his discretion in respect of) each resolution dealing with any such business; and

(2) unless the contrary is stated herein, be valid as well for any adjournment of the meeting as for the meeting to which it relates.

94. A vote given in accordance with the terms of an instrument of proxy or power of attorney shall be valid notwithstanding the previous death or insanity of the principal or revocation of the proxy or power of attorney or other authority under which the proxy was executed or the transfer of the share in respect of which the proxy is given, provided that no intimation in writing of such death, insanity, revocation or transfer as aforesaid shall have been received by the Company at its Head Office (or at such other place in the Relevant Territory specified for the deposit of instrument or proxies hereunder) at least twenty-four (24) hours before the commencement of the meeting or adjourned meeting or meetings at which the proxy or power of attorney is used.

- Corporation acting 95.(A) Any corporation which is a member of the Company may, by by representatives resolution of its directors or other governing body or by power at meetings of attorney, authorise such person as it thinks fit to act as its representative to attend and vote at any general meeting of the Company or of any class of members of the Company, and the person so authorised shall be entitled to exercise the same powers on behalf of the corporation which he represents as that corporation could exercise as if it were an individual member of the Company and such corporation shall for the purposes of these Bye-laws be deemed to be present at any such meeting if a person so authorised is present thereat. References in these Bye-laws to a member present in person at a meeting shall, unless the context otherwise requires, include a corporation which is a member represented at the meeting by such duly authorised representative.
  - (B) Subject to the Companies Act, where a member is the clearing house (or its nominee), it may appoint or authorise such person

When vote by proxy valid though authority revoked or persons as it thinks fit to act as its proxy/proxies or corporate representative/representatives, who enjoy rights equivalent to the rights of other members, to attend any meeting of the Company (including but not limited to general meetings and creditors meetings) or at any meeting of any class of members provided that, if more than one person is so authorised, the authorisation shall specify the number and class of shares in respect of which each such person is so authorised. A person so authorised under the provisions of this Bye-law shall be entitled to exercise the same powers on behalf of the clearing house (or its nominee) which he represents as the clearing house (or its nominee) could exercise as if it were an individual member, including the right to speak and to vote individually on a show of hands or on a poll.

Constitution of Board	97.	Unless and until otherwise determined by the Company by Ordinary Resolution the number of Directors shall not be less than 2 and there shall be no maximum number of Directors. The Directors shall be elected or appointed in the first place at the statutory meeting of members and thereafter in accordance with the next following Bye-law. The Board shall cause to be kept a register of the Directors and officers at its Registered Office and Head Office in accordance with the Companies Act.
Retirement of Directors	98.	Notwithstanding any other provisions in the Bye-laws, at each annual general meeting, one-third of the Directors for the time being, or, if their number is not three (3) or a multiple of three (3), then the number nearest to but not less than one-third, shall retire from office by rotation but shall be eligible for re-election, provided that every Director shall be subject to retirement at least once every three years. The Directors to retire in every year shall be those who have been longest in office since their last election but as between persons who became Directors on the same day those to retire shall (unless they otherwise agree between themselves) be determined by lots.
Retiring Directors to remain in office till successors appointed	99.	If at any general meeting at which an election of Directors ought to take place, the places of the retiring Directors are not filled,

the retiring Directors or such of them as have not had their places filled shall be deemed to have been re-elected and shall, if willing, continue in office until the next annual general meeting and so on from year to year until their places are filled, unless:

- (1) it shall be determined at such meeting to reduce the number of Directors; or
- (2) it is expressly resolved at such meeting not to fill up such vacated offices; or
- (3) in any such case the resolution for re-election of a Director is put to the meeting and lost; or
- (4) such Director has given notice in writing to the Company that he is not willing to be re-elected.
- Power of general meeting to increase or reduce number of directors 100. The Company in general meeting may from time to time fix and may by Ordinary Resolution increase or reduce the maximum and minimum number of Directors but so that the number of Directors shall not be less than two (2) at all times.
- Notice to be given 101. No person, other than a retiring Director, shall, unless of person proposed recommended by the Directors for election, be eligible for for election election to the office of director at any general meeting, unless notice in writing signed by a member (not being the person to be proposed) duly qualified to be present and vote at the meeting for which such notice is given of his intention to propose at the meeting that person for election as a Director and notice in writing signed by that person to be proposed of his willingness to be elected shall have been lodged at the Head Office provided that the minimum length of the period, during which such notice(s) are given, shall be at least seven (7) days and that the period for lodgment of such notice(s) shall commence no earlier than the day after the despatch of the notice of the general meeting appointed for such election and end no later than seven (7) days prior to the date of such general meeting.
- Power to remove 102. The members may by Ordinary Resolution at any general meeting convened and held in accordance with these Bye-laws remove any Director (including a managing or other executive director) before the expiration of his term of office notwithstanding anything in these Bye-laws or in any agreement between the Company and such Director (but

without prejudice to any claim which such Director may have for damages for any breach of any contract of service between him and the Company), provided that notice of any such meeting shall be served on the Director concerned not less than fourteen (14) days before the meeting and such Director shall be entitled to be heard at such meeting on the motion of his removal. The Company may by Ordinary Resolution elect another person in his stead. Any person so elected shall hold office for such time only as the Director in whose place he is elected would have held the same if he had not been removed.

- General meeting to elect Directors 103.(A) The Company may from time to time in general meeting by Ordinary Resolution elect any person to be a Director either to fill a casual vacancy or as an addition to the Board.
- Board may fill vacancy
  (B) The Board shall have power from time to time and at any time to appoint any person as a Director to fill a casual vacancy on the Board and, subject to the authorization by the members in general meeting, the Board shall until and unless such authorisation is revoked have power from time to time and at any time to appoint any person as an addition to the Board but so that the number of Directors so appointed shall not exceed the maximum number determined from time to time by members in general meeting. Any Director so appointed shall hold office only until the first annual general meeting of the Company after his appointment, and shall then be eligible for re-election at that meeting.
- Alternate Director 104.(A) A Director may at any time, by notice in writing signed by him delivered to the Registered Office or at the Head Office or at a meeting of the Board, appoint any person (including another Director) to act as an alternate Director in his place and may in like manner at any time determine such appointment.
  - (B) The appointment of an alternate Director shall determine on the happening of any event which, were he a Director, would cause him to vacate such office or if his appointor ceases to be a Director provided that if any Director retires at a general meeting but is re-elected by the meeting or is, pursuant to the provisions of these Bye-laws, deemed to be re-elected at the meeting at which such retirement took place, any appointment made by him pursuant to this Bye-law which was in force immediately prior to his retirement shall continue to operate after such re-election as if he had not so retired.

- An alternate Director, except when absent from the Relevant (C) Territory shall be entitled (subject to his giving the Company an address within the Relevant Territory at which notices may be served on him) to receive and waive notices of meetings of the Directors and shall be entitled to attend and vote and be counted in the quorum of such meeting as a Director at any such meeting at which the Director appointing him is not personally present, and generally at such meeting to exercise all the powers, rights, duties and authorities and to perform all functions of the Director appointing him. For the purpose of the proceedings at such meeting if an alternate Director acts as alternate for more than one Director, he shall be counted in the quorum separately in respect of himself (if a Director) and in respect of each Director for whom he is an alternate and his voting rights shall be cumulative and he need not use all his votes or cast all the votes he uses in the same way. A Director who is also an alternate Director shall be entitled in addition to his own vote to a separate vote on behalf of the Director appointing him.
- The signature of an alternate Director to any resolution in (D) writing of the Board shall, unless the notice of his appointment provides to the contrary, be effective as the signature of his appointor. To such extent as the Board may from time to time determine in relation to any committee of the Directors, the foregoing provisions of this paragraph shall also apply mutatis mutandis to any meeting of any such committee of which his appointor is a member. An alternate Director shall not, save as aforesaid, have power to act as a Director nor shall he be deemed to be a Director for the purposes of these Bye-laws. Every person acting as an alternate Director shall be an officer of the Company, and shall alone be responsible to the Company for his own acts and defaults, and he shall not be deemed to be the agent of or for the Director appointing him. A Director shall not be liable for the acts or defaults of any alternate Director appointed by him.
- (E) A Director may appoint two or more persons in the alternative to act as alternate Director and in the event of any dispute as to who is to represent the Director as his alternate the first named of such alternative persons shall be the only person recognised as the alternate Director and shall in any case, if in the Relevant Territory, be the only person entitled to receive notice of Directors' meetings in the absence of his appointor from the Relevant Territory.

Appointment of two or more alternates

- (F) An alternate Director shall be entitled to contract and be interested in and benefit from contracts or arrangements or transactions and to be repaid expenses and to be indemnified to the same extent mutatis mutandis as if he were a Director, but he shall not be entitled to receive from the Company in respect of his appointment as an alternate Director any remuneration except only such part (if any) of the remuneration otherwise payable to his appointor as such appointor may by notice in writing to the Company from time to time direct.
- (G) No alternate Director shall by virtue of that position be a director for the purposes of the Companies Act, but shall nevertheless be subject to the provisions of the Companies Act in so far as they relate to the duties and obligations of directors (other than the obligations to hold any qualifying share in the Company) when performing the functions of a Director.
- Qualification of Directors 105. A Director or an alternate Director shall not be required to hold any qualification shares but shall nevertheless be entitled to attend and speak at all general meetings of the Company and of any class of members of the Company. No Director shall be required to vacate office or be ineligible for re-election or reappointment as a Director and no person shall be ineligible for appointment as a Director by reason only of his having attained any particular age.
- Directors' The Directors shall be entitled to receive by way of 106.(A) remuneration remuneration for their services as Directors such sum as shall from time to time be determined by the Company in general meeting, such sum (unless otherwise directed by the resolutions by which it is voted) to be divided amongst the Directors in such proportions and in such manner as the Board may agree, or failing agreement, equally, except that in such event any Director holding office for less than the whole of the relevant period in respect of which the remuneration is paid shall only rank in such division in proportion to the time during such period for which he has held office. The foregoing provisions shall not apply to a Director who holds any salaried employment or office in the Company except in the case of sums paid in respect of Director's fees.
  - (B) Payment to any Director or past Director of any sum by way of compensation for loss of office or as consideration for or in connection with his retirement from office (not being a payment to which the Director is contractually entitled) must be approved by the Company in general meeting.

- Directors' expenses 107. The Directors shall also be entitled to repaid or prepaid all travelling, hotel and other expenses reasonably incurred or expected to be incurred by them respectively in or about the performance of their duties as Directors, including their expenses of travelling to and from board meetings, committee meetings or general meetings or separate meetings of any class of shares or of debenture of the Company or otherwise incurred whilst engaged on the business of the Company or in the discharge of their duties as Directors.
- Special<br/>remuneration108.The Board may grant special remuneration if any Director who<br/>having been called upon and being willing to do so, shall render<br/>or perform any special or extra services to or at the request of<br/>the Company including travelling or residing abroad for any<br/>business of the Company. Such special remuneration may, as<br/>the Board shall determine, be made payable to such Director<br/>either in addition to or in substitution for his ordinary<br/>remuneration as a Director, and may be made payable by way<br/>of salary, commission or participation in profits or otherwise as<br/>may be arranged and the same shall be charged as part of the<br/>ordinary working expenses of the Company.
- Remuneration of Managing Directors, etc
  109. Notwithstanding Bye-law 106, 107 and 108, the remuneration of a Managing Director, Joint Managing Director, Deputy Managing Director or other Executive Director or a Director appointed to any other office in the management of the Company shall from time to time be fixed by the Board and may be by way of salary, commission, or participation in profit or otherwise or by all or any of those modes and with such other benefits (including pension and/or gratuity and/or other benefits on retirement) and allowances as the Board may from time to time decide. Such remuneration shall be either in addition to or in lieu of his remuneration as a Director.

When office of Director to be vacated

A Director shall vacate his office:

- if he becomes bankrupt or has a receiving order made against him or suspends payment or makes any arrangement or composition with his creditors generally;
- (2) if he becomes a lunatic or of unsound mind;
- (3) if he absents himself from meetings of the Board or his office as a Director during a continuous period of six (6) months, without special leave of absence from the Board, whether or not any alternate Director appointed by him attends such meeting of the Board and the Board resolves that he has by reason of such absence vacated his office;
- (4) if he becomes prohibited from acting as a Director by law or by reason of any order made by any court of competent jurisdiction;
- (5) if he resigns his office by notice in writing delivered to the Company at its Head Office or submitted to a meeting of the Board;
- (6) if, having been appointed to an office under Bye-law 112, he is dismissed or removed therefrom by the Board under Bye-law 113; or
- (7) if he shall be removed from office by an Ordinary resolution of the Company under Bye-law 102.
- 111.(A) Subject to the Companies Act and to these Bye-laws, no Director or proposed or intended Director shall be disqualified by his office from contracting with the Company, either with regard to his tenure of any office or place of profit or as vendor, purchaser or in any manner whatever, nor shall any such contract or any other contract or arrangement entered into by or on behalf of the Company with any person, company or partnership of or in which any Director shall be a member or otherwise interested in any way be liable on that account to being avoided, nor shall any Director so contracting or being any member or so interested be liable to account to the Company or the members for any remuneration, profit or other benefits realised by any such contract or arrangement by reason only of such Director holding that office or the fiduciary relationship thereby established.

Directors may contract with the Company

- (B) A Director who to his knowledge is in any way, whether directly or indirectly, interested in any contract or arrangement with the Company shall declare the nature of his interest at the meeting of the Board at which the question of entering into the contract or arrangement is first taken into consideration, if he knows his interest then exists, or in any other case at the first meeting of the Board after he knows that he is or has become so interested. For the purposes of this Bye-law, a general notice to the Board by a Director that (a) he is a member of a specified company or firm and is to be regarded as interested in any contract or arrangement which may after the date of the notice be made with that company or firm or (b) by reason of the facts specified in the notice, he is to be regarded as interested in any contract or arrangement which may be made with any specified person after the date of such notice shall be a sufficient declaration of interest in relation to any contract or arrangement so made, provided that no such notice shall be of effect unless it is given at a meeting of the Board at which it is practicable for him to do so or the Director takes reasonable steps to secure that it is brought up and read at the next Board meeting after it is given.
- (C) A Director shall not vote (nor be counted in the quorum) on any resolution of the Board approving any contract or arrangement or any other proposal in which he or any of his associate(s) is/are to his/their knowledge materially interested, but this prohibition shall not apply to any of the following matters:
  - (1) the giving of any security or indemnity either:
    - (a) to the Director or his close associate(s) in respect of money lent or obligations incurred or undertaken by him or any of them at the request of or for the benefit of the Company or any of its subsidiaries; or
    - (b) to a third party in respect of a debt or obligation of the Company or any of its subsidiaries for which the Director or his close associate(s) has/have himself/themselves assumed responsibility in whole or in part and whether alone or jointly under a guarantee or indemnity or by the giving of security;
  - (2) any proposal concerning an offer of shares or debentures or other securities of or by the Company or any other company which the Company may promote or be interested in for subscription or purchase where the

Director or his close associate(s) is/are or is/are to be interested as a participant in the underwriting or subunderwriting of the offer;

(3) any contract or arrangement in which the Director or his close associate(s) is/are interested in the same manner as other holders of shares or debentures or other securities of the Company by virtue only of his/their interest in shares or debentures or other securities of the Company; and

#### (4) INTENTIONALLY DELETED

- (5) any proposal or arrangement concerning the benefit of employees of the Company or its subsidiaries including:
  - (a) the adoption, modification or operation of any employees' share scheme or any share incentive or share option scheme under which the Director or his close associate(s) may benefit; or
  - (b) the adoption, modification or operation of a pension fund or retirement, death or disability benefits scheme which relates to the Director, his close associate(s) and employee(s) of the Company or any its subsidiaries and does not provide in respect of any Director, or his close associate(s), as such any privilege or advantage not generally accorded to the class of persons to which such scheme or fund relates;

(F) If any question shall arise at any meeting of the Board as to the materiality of the interest of a Director (other than the Chairman of the meeting) or his close associate(s) or the entitlement of any Director (other than such Chairman) to vote or be counted in a quorum and such question is not resolved by his voluntarily agreeing to abstain from voting or not be counted in the quorum, such question shall be referred to the Chairman of the meeting and his ruling in relation to such other Director shall be final and conclusive except in a case where the nature or extent of the interest of the Director and/or his close associate(s) concerned as known to such Director has not been fairly disclosed to the Board. If any question as aforesaid shall arise

in respect of the Chairman of the meeting, such question shall be decided by a resolution of the Board (for which purpose such Chairman shall not be counted in the quorum and shall not vote thereon) and such resolution shall be final and conclusive except in a case where the nature or extent of the interest of such Chairman and/or his close associate(s) as known to such Chairman has not been fairly disclosed to the Board.

- A Director may hold any other office or place of profit with the (G) Company (except that of Auditor) in conjunction with his office of Director for such period and upon such terms as the Board may determine, and may be paid such extra remuneration therefor (whether by way of salary, commission, participation in profits or otherwise) as the Board may determine. The Board may exercise the voting powers conferred by the shares in any other company held or owned by the Company, or exercisable by members of the Board as directors of such other company in such manner in all respects as it thinks fits including the exercise thereof in favour of any resolution appointing the Directors or any of them to be directors or officers of such other company, or voting or providing for the payment of remuneration to the directors or other officers of such other company.
- Subject to the provisions of the Companies Act, a Director may (H) be or become a director or other officer of, or otherwise interested in, any company promoted by the Company or any other company in which it may be interested as a vendor, shareholder or otherwise in any way and no such Director shall be accountable to the Company or the members for any remuneration, profit or other benefits received by him as a director or officer or employee of or from his interest in such other company. Subject to the provisions of these Bye-laws, a Director may also exercise the voting power conferred by the shares in any other company held or owned by the Company or exercisable by a member of the board of directors of such company in such manner in all respects as he thinks fit, including the exercise thereof in favour of any resolution appointing the Directors to be a director or officer or employee of such other company, or voting or providing for the payment of remuneration to him as a director or officer or employee of such other company.
- (I) A Director may act by himself or by his firm in a professional capacity for the Company and he or his firm shall be entitled to

remuneration for professional services as if he were not a Director but a Director or his firm shall not act as Auditors to the Company.

- (J) A Director shall not vote or be counted in the quorum on any resolution of the Board concerning his own appointment as the holder of any office or place of profit with the Company or any other company in which the Company is interested (including the adoption of the arrangement or variations of the terms thereof, or the termination thereof).
- (K) Where arrangements are under consideration concerning the appointment (including the adoption of the arrangement or variation of the terms thereof, or the termination thereof) of two or more Directors to offices or places of profit with the Company or any other company in which the Company is interested, separate resolution may be put in relation to each Director and in such case each of the Directors concerned shall be entitled to vote (and be counted in the quorum) in respect of each resolution except that concerning his own appointment (or the arrangement or variation of the terms thereof, or the termination thereof).

# MANAGING DIRECTORS, ETC.

Power to appoint Managing Directors, etc.	112.	The Board may from time to time appoint any one or more of its body to the office of Managing Director, Joint Managing Director, Deputy Managing Director, or other Executive Director and/or to hold any other employment or executive office with the Company in the management of the business of the Company as it may decide for such period and upon such terms as it thinks fit and upon such terms as to remuneration as it may decide in accordance with Bye-law 109.
Removal of Managing Directors, etc.	113.	Every Director appointed to an office under Bye-law 112 shall be liable to be dismissed or removed therefrom by the Board. Any such dismissal or removal as aforesaid shall be without prejudice to any claim for damages for any breach of any contract of service between him and the Company.
Cessation of appointment	114.	A Director appointed to an office under Bye-law 112 shall be subject to the same provisions as to rotation, resignation and removal as the other Directors of the Company, and he shall <u>ipso facto</u> and immediately cease to hold such office if he shall cease to hold the office of Director for any cause.

Powers may be delegated 115. The Board may from time to time entrust to and confer upon a Managing Director, Joint Managing Director, Deputy Managing Director or Executive Director all or any of the powers exercisable under these Bye-laws by the Board that it may think fit provided that the exercise of all powers by such Director shall be subject to such regulations and restrictions as the Board may from time to time make and impose, and the said powers may at any time be withdrawn, revoked or varied, but no person dealing in good faith and without notice of such withdrawal, revocation of variation shall be affected thereby.

#### MANAGEMENT

General Powers of The management of the business of the Company shall be 116.(A) Company vested in vested in the Board which, in addition to the powers and Board authorities by these Bye-laws expressly conferred upon it, may exercise all such powers and do all such acts and things as may be exercised or done or approved by the Company and which are not hereby or by the Companies Act required to be exercised or done by the Company in general meeting, but subject nevertheless to the provisions of the Companies Act and of these Bye-laws and to any regulations from time to time made by the Company in general meeting not being inconsistent with such provisions provided that no regulation so made shall invalidate any prior act of the Directors which would have been valid if such regulation had not been made.

- (B) Without prejudice to the general powers conferred by these Bye-laws, it is hereby expressly declared that the Board shall have the following powers:
  - to give to any person the right or option of requiring at a future date that an allotment shall be made to him of any share at par or at such premium as may be agreed;
  - (2) to give to any Directors, officers or servants of the Company an interest in any particular business or transaction or participation in the profits thereof or in the general profits of the Company either in addition to or in substitution for a salary or other remuneration; and
  - (3) to exercise all the powers of the Company to borrow money and to mortgage or charge all or any part of the undertaking, property and assets (present and future) and uncalled capital of the Company and to issue debenture, debenture stocks,

bonds and other securities, whether outright or as collateral security for any debt, liability or obligation of the Company or any third party

Local board 117. The Board may establish any committee, regional or local board or agency for managing any of the affairs of the Company, either in Bermuda, the Relevant Territory or elsewhere, and may appoint any persons to be members of such committee, regional or local boards or agencies and may fix their remuneration, and may delegate to any committee, regional or local board or agency any of the powers, authorities and discretions vested in the Board (other than its powers to make calls and forfeit shares), with power to sub-delegate, and may authorise the members of any committee or regional or local board or agency or any of them to fill any vacancies therein and to act notwithstanding vacancies, and any such appointment or delegation may be upon such terms and subject to such conditions as the Board may think fit, and the Board may remove any person so appointed and may annul or vary any such delegation, but no person dealing in good faith and without notice of any such annulment or variation shall be affected thereby.

Power of establish 118. The Board may establish and maintain or procure the pension funds establishment and maintenance of any contributory or noncontributory scheme or superannuation funds for the benefit of, or give or procure the giving of donations, gratuities, pensions, allowances, emoluments or other benefits to, any person who are or were at any time in the employment or service of the Company, or of any company which is a subsidiary of the Company, or is allied or associated with the Company or with any such subsidiary company, or who are or were at any time Directors or officers of the Company or of any such other company as aforesaid, or who hold or have held any salaried employment or office in the Company or such other company, and the spouses, widows, widowers, families and dependents of any such persons. The Board may also establish and subsidise or subscribe to any institutions, associations, clubs or funds calculated to be for the benefit of or to advance the interests and well-being of the Company or of any such other company or persons as aforesaid and may make payments for or towards the insurance of any such persons as aforesaid, and subscribe or guarantee money for charitable or benevolent objects or for any exhibition or for any public, general or useful object. The Board may do any of the matters aforesaid, either alone or in conjunction with any such other company as aforesaid. Any Director holding any such employment or office shall be entitled to participate in and retain for his own benefit any such donation, gratuity, pension, allowance or emolument.

#### MANAGERS

Appointment and remuneration of managers	119.	The Board may from time to time appoint a general manager, manager or managers of the business of the Company and may fix his or their remuneration either by way of salary or commission or by conferring the right to participation in the profits of the Company or by a combination of two or more of these modes and pay the working expenses of any of the staff of the general manager, manager or managers who may be employed by him or them upon the business of the Company. (as amended by special resolution passed on $23^{rd}$ June, 2014)

Tenure of office and powers 120. The appointment of such general manager, manager or managers may be for such period as the Board may decide and the Board may confer upon him or them all or any of the powers of the Board as it may think fit.

Terms and conditions of appointment 121. The Board may enter into such agreements with any such general manager, manager or managers upon such terms and conditions in all respects as the Board may in its absolute discretion think fit, including a power for such general manager, manager or managers to appoint an assistant manager or managers or other employees whatsoever under them for the purpose of carrying on the business of the Company.

#### CHAIRMAN AND HONOURARY CHAIRMAN

Co-Chairmen The Company shall have two (2) co-chairmen at all times. The 122.(A) Board may from time to time elect amongst the Directors two co-chairmen and appoint other officers and determine the period for which each of them is to hold office. The Board may elect one of the co-chairmen of the Company as the Chairman of its meetings and determine the period for which he will hold such office. The elected co-chairman or, in his absence, the other co-chairman of the Company shall preside as the Chairman of a meeting of the Board. If no Chairman of the meeting is elected, or if at any meeting neither of the cochairmen present after five (5) minutes after the time appointed for holding the same, the Directors may choose one of their number to be Chairman of the meeting. Subject to Bye-law 98, all the provisions of Bye-law 113, 114 and 115 shall mutatis mutandis apply to any Directors elected or otherwise appointed to any office in accordance with the provisions of this Bye-law.

(B) The Directors may from time to time appoint any person to the position of Honourary Chairman of the Company and delegate to him such non-executive powers and alter and revoke any such delegation of powers as they consider fit from time to time. The Honourary Chairman is not a Director and may be removed by the Directors.

### PROCEEDINGS OF DIRECTORS

Meetings of 123. The Directors may meet together for the despatch of business, Directors adjourn or postpone and otherwise regulate their meetings and Quorums, etc proceedings as they think fit and may determine the quorum necessary for the transaction of business. Unless otherwise determined, two (2) Directors shall be a quorum. For the purpose of this Bye-law, an alternate director shall be counted in the quorum but, notwithstanding that an alternate director is also a Director or is an alternate for more than one Director, he shall for quorum purposes be counted as only one Director. The Board or any committee of the Board may participate in a meeting of the Board or such committee by means of a conference telephone or similar communications equipment by means of which all persons participating in the meeting are capable of hearing each other and, for the purpose of counting a quorum, such participation shall constitute presence at a meeting as if those participating were present in person.

Convening a board 124. A Director may, and on the request of a Director, the Secretary meeting shall, at any time summon a meeting of the Board. Notice thereof shall be given to each Director and alternate Director either in writing or verbally (including in person or by telephone or by telex or telegram at the address, telephone, telex or telegram number) or by electronic means to an electronic address from time to time notified to the Company by such Director or (if the recipient consents to it being made available on a website) by making it available on a website or by telephone from time to time notified to the Company by such Director or in such other manner as the Board may from time to time determine accompanied or followed by an agenda specifying the business to be transacted thereat. No decision shall be reached at a meeting of the board on any matter which has not been referred to in the agenda. A Director absent or intended to be absent from the Relevant Territory may request the Board that notices of Board meetings shall during his absence be sent in writing to him at his last known address or any other address given by him to the Company for this purpose, but such notices need not be given any earlier than notices given to Directors not so absent and in the absence of any such request it shall not be necessary to give notice of a Board meeting to any Director who is for the time being absent from the Relevant Territory. A Director may waive notice of any meeting of the Board and any such waiver may be retrospective or may be a general waiver sine die or in respect of a number of meetings. A meeting of the Board shall be deemed to be duly and validly convened notwithstanding that it is called by shorter or irregular notice if all the Directors entitled to receive notice of and attend such meeting have so agreed. How questions to 125. Questions arising at any meeting of the Board shall be decided be decided

Power of meeting 126. A meeting of the Board for the time being at which a quorum is present shall be competent to exercise all or any of the authorities, powers and discretions by or under these Bye-laws for the time being vested in or exercisable by the Board generally.

Power to appoint committee and to delegate 127. The Board may delegate any of its powers, authorities and discretions to committees consisting of such member or members of its body and such other persons as it thinks fit, and it may from time to time revoke such delegation or revoke the appointment of and discharge any committee either wholly or in part, and either as to persons or purposes, but every committee so formed shall in the exercise of the powers, authorities and discretions so delegated conform to any regulations that may from time to time be imposed upon it by the Board. The Board may authorise the members of any such committee or any of them, to fill any vacancy therein and to act notwithstanding such vacancies.

Acts of committee to be of same effect as act of Board 128. All acts done by any such committee referred to in Bye-law 127 in conformity with such regulations and in fulfillment of the purposes for which it is appointed, but not otherwise, shall have the like force and effect as if done by the Board, and the Board shall have power, with the consent of the Company in general meeting, to remunerate the members of any special committee, and charge such remuneration to the current expenses of the Company.

Proceedings of committee 129. The meetings and proceedings of any such committee referred to in Bye-law 127 consisting of two (2) or more members shall be governed mutatis mutandis by the provisions herein contained for regulating the meetings and proceedings of the Board so far as the same are not superseded by any restrictions imposed upon such committee by the Board under these Byelaws.

When acts of 130. All acts bona fide done by any meeting of the Board or by a Directors or committee of Board or by any person acting as a Director shall, committee to be valid notwithstanding that it shall be afterwards discovered that there notwithstanding was some defect in the appointment of such Director or persons defects acting as aforesaid or that they or any of them were disqualified or had vacated office, be as valid as if every such person had been duly appointed and was qualified or had continued to be a Director or member of such committee as regards all persons dealing with the Company in good faith.

Directors' powers when vacancies exist 131. The continuing Directors may act notwithstanding any vacancy in their body, but, if and so long as their number is reduced below the number fixed by or pursuant to these Bye-laws as the necessary quorum of a board meeting, the continuing Director or Directors may act for the purpose of increasing the number of Directors to that number or of summoning a general meeting of the Company but for no other purpose.

Directors' resolutions	132.	A resolution in writing signed by each and every one of the Directors (or his alternate Director pursuant to Bye-law 104(D)) for the time being entitled to receive notice of a meeting of the Board shall be valid and effectual as if it had been passed at a meeting of the Board duly convened, held and constituted and may consist of several documents in like form each signed by one or more of the Directors or his or their alternate Director. A resolution purporting to have been transmitted by a Director (or his alternate) to the Company by telegram, telex, telecopier or other facsimile equipment shall be deemed to be a document signed by him for the purpose of this Bye-law.
Power to authenticate documents	133.	A Director or the Secretary or any person appointed by the Board for the purpose shall have power to authenticate any documents affecting the constitution of the Company and any resolution passed by the Company or the Board or any committee of the Board and any books, records, documents and accounts relating to the business of the Company and to certify copies thereof or extracts therefrom as true copies or extracts; and where any books, records, documents or accounts are elsewhere than at the Head Office the local manager or other officer of the Company having the custody thereof shall be deemed to be the person appointed by the Board as aforesaid.
Documents authenticated as above to be conclusive	134.	A document purporting to be a copy of a resolution or an extract from the minutes of a meeting of the Board or of committee of the Board which is certified as such in accordance with the provisions of Bye-law 133 shall be conclusive evidence in favour of all persons dealing with the Company upon the faith thereof that such resolution has been duly passed or as the case may be that such extract is a true and accurate record of a duly constituted meeting of the Board or of the committee. - (D) Any register, index, minute book, book of account or other book required by these Bye-laws or the Companies Act to be kept by or on behalf of the Company may be kept either by making entries in bound books or by recording them in any other manner which shall include, without prejudice to the generality thereof, recording by means of magnetic tape, microfilm, computer or any other non-manual system of recording. In any case in which bound books are not used, the Directors shall take adequate precautions for guarding against falsification and for facilitating its discovery.

# SECRETARY

Appointment of Secretary	136.	The Secretary shall be appointed by the Board for such term, with such remuneration and upon such conditions as it may think fit. Any Secretary so appointed may be removed from office by the Board but without prejudice to any claim for damages for breach of any contract or service between him and the Company if such a contract of service exists. The Board may also appoint from time to time on such terms as it thinks fit one or more assistant, temporary or deputy Secretaries. Anything by the Companies Act or these Bye-laws required or authorised to be done by or to the Secretary, if the office is vacant or there is for any other reason no Secretary capable of acting, may be done by or to any assistant, temporary or deputy Secretary, or if there is no assistant or deputy Secretary capable of acting, by or to any officer of the Company authorised generally or specifically in that behalf of the Board.
Duties of Secretary	137.	The duties of the Secretary shall be those specified by the Companies Act and these Bye-laws, together with such other duties as may from time to time be prescribed by the Board.
Same person not to act in two capacities	138.	Any provisions of the Companies Act or these Bye-laws requiring or authorising a thing or an act be done by or to a

Director and the Secretary shall not be satisfied by it being done by or to the same person acting both as Director and as, or in the place of, the Secretary.

# THE SEAL

Custody of seal 139. The Company may authorize the production of one or more Seals. The Board shall provide for the safe custody of each Seal, and no Seal shall be used without the authority of the Board or a committee of the Board authorized by the Board in that behalf.

> In the event that the Board does not authorize the production of a Seal, any document required to be under Seal or executed as a deed on behalf of the Company shall be signed or executed by any person authorized by the Board for that purpose.

> Subject to these Bye-laws, any instrument to which a Seal is affixed shall be signed autographically by one Director and the Secretary, or by 2 Directors, or by any person or persons (including a Director and /or the Secretary) authorized by the Board for that purpose, provided that as regards any certificates for shares or debentures or other securities of the Company the Directors may by resolution determine that such signature shall be dispensed with or affixed by some method or system of mechanical signature other than autographic as specified in such resolution or that such certificates need not be signed by any person.

Securities Seal 140. The Company may have a securities seal for use for sealing certificates for shares or other securities issued by the Company and no signature of any Director, officer or other person and no mechanical reproduction thereof shall be required on any such certificates or other document and any such certificates or other document to which such securities seal is affixed shall be valid and deemed to have been sealed and executed with the authority of the Board notwithstanding the absence of any such signature or mechanical reproduction as aforesaid.

Cheques and banking arrangements 141. All cheques, promissory notes, drafts, bills of exchange and other negotiable instruments, and all receipts for moneys paid to the Company shall be signed, drawn, accepted, indorsed or otherwise executed, as the case may be, in such manner as the Board shall from time to time by resolution determine. The Company's bank accounts shall be kept with such banker or bankers as the Board shall from time to time determine.

- Power to appoint 142.(A) The Board may from time to time and at any time, by power of attorney attorney appoint any company, firm or person or any fluctuating body of persons, whether nominated directly or indirectly by the Board, to be the attorney or attorneys of the Company for such purposes and with such powers, authorities and discretions (not exceeding those vested in or exercisable by the Board under these Bye-laws) and for such period and subject to such conditions as it may think fit, and any such power of attorney may contain such provisions for the protection and convenience of persons dealing with any such attorney as the Board may think fit, and may also authorize any such attorney to subdelegate all or any of the powers, authorities and discretions vested in him.
- Execution of deeds by attorney (B) The Company may in writing empower any person, either generally or in respect of any specified matter, as its attorney to execute deeds and instruments on its behalf and to enter into contracts and sign the same on its behalf and every deed signed by such attorney on behalf of the Company shall bind the Company.

# DESTRUCTION OF DOCUMENTS

and it shall conclusively be presumed in favour of the Company that every entry in the register purporting to be made on the basis of any such documents so destroyed was duly and properly made and every share certificate so destroyed was a valid certificate duly and properly cancelled and that every instrument of transfer so destroyed was a valid and effective instrument duly and properly registered and that every other document destroyed hereunder was a valid and effective document in accordance with the recorded particulars thereof in the books or records of the Company. Provided always that:

- (i) the foregoing provisions of this Bye-law shall apply only to the destruction of a document in good faith and without express notice to the Company that the preservation of such document was relevant to a claim;
- (ii) nothing contained in this Bye-law shall be construed as imposing upon the Company any liability in respect of the destruction of any such document earlier than as aforesaid or in any case where the conditions of provison (1) above are not fulfilled; and
- (iii) references in this Bye-law to the destruction of any document include references to its disposal in any manner.

#### RESERVES

Reserves 144. The Board may, before recommending any dividend, whether preferential or otherwise, set aside out of the profits of the Company such sums as it thinks proper as a reserve or reserves which shall, at the discretion of the Board, be applicable for meeting claims on or liabilities of the Company or contingencies or for paying off any loan capital or for equalising dividends or for any other purpose to which the profits of the Company may be properly applied, and pending such application may, at the like discretion, either be employed in the business of the Company or be invested in such investments (other than shares of the Company) as the Board may from time to time think fit, and so that it shall not be necessary to keep any reserve separate or distinct from any other investments of the Company. The Board may also without placing the same to reserve carry forward any profits which it may think prudent not to distribute by way of dividend.

## CAPITALISATION OF RESERVES

Power to capitalise The Company in general meeting may by Ordinary Resolution 145. upon the recommendation of the Board resolve that it is desirable to capitalise any part of the amounts for the time being standing to the credit of any of the Company's reserve accounts (including any contributed surplus account and also including any share premium account or other undistributable reserve, but subject to the provisions of the Companies Act with regard to unrealised profits) or to the credit of the profit and loss account or otherwise available for distribution and not required for the payment or provision of fixed dividend on any shares entitled to fixed preferential dividends with or without further participation in profits and that the Board be accordingly authorised and directed to appropriate the profits or sum so reserved to be capitalised and be sub-divided to the members in the proportion in which such profits or sum would have been divisible amongst them had the same been applied or been applicable in paying dividends on the shares held by them on such date as shall be fixed by or in accordance with such resolutions, and to apply such profits or sum on their behalf either in or towards paying up any amounts, if any, for the time being unpaid on any shares held by such members respectively, or in the paying up in full of unissued shares or debentures of the Company of a nominal amount equal to such profits or sum, such shares or debentures to be allotted and distributed, credited as fully paid up, to and amongst such members in proportion aforesaid, or partly in one way and partly in the other, provided that for the purpose of this Bye-law, and subject to Section 40(2A) of the Companies Act, any amount standing to the credit of share premium account and any reserve or fund representing unrealised or other undistributable profits may only be applied in paying up of unissued shares to be issued to members of the Company as fully paid up shares. In carrying sums to reserve and in applying the same, the Board shall comply with the provisions of the Companies Act.

Effect of resolution 146.(A) Whenever such a resolution as referred to in Bye-law 145 shall have been passed the Board shall make all appropriations and

applications of the reserves and undivided profits resolved to be capitalised thereby, and all allotments and issues of fully paid shares, debentures or other securities, if any, and generally shall do all acts and things required to give effect thereto, with full power to settle any difficulty which may arise with regard to a capitalisation issue as the Board may think fit, and in particular may disregard fractional entitlements to shares or debentures or round the same up or down, and with full power to make such provision by the issue of fractional certificates and the Board may determine that cash payments shall be made to any members in lieu of fractional entitlements or that fractions of such value as the Board may determine may be disregarded in order to adjust the rights of all parties or that fractional entitlements shall be aggregated and sold and the benefit shall accrue to the Company rather than to members concerned. The Board may also authorise any person to enter on behalf of all members entitled thereto into an agreement with the Company providing allotment to them respectively, credited as fully paid up, of any further shares, debentures or other securities to which they may be entitled upon such capitalisation or, as the case may require, for the payment up by the Company on their behalf, by the application thereto of their respective proportions of the profits resolved to be capitalised, of the amounts or any part of the amounts remaining unpaid on their existing shares, and any agreement made under such authority shall be effective and binding on all such members. The Board may resolve that no such allotments and issues of fully paid-up shares or debentures or securities shall be made available or made to shareholders with registered addresses in any particular territory or territories being a territory or territories where, in the absence of a registration statement or other special formalities, this would or might, in the opinion of the Board, be unlawful or impracticable and in such event the Board may make such alternative arrangements for the shareholders aforesaid as it thinks expedient including authorising any person to sell the shares or debentures to which the aforesaid shareholders are otherwise entitled and the only entitlement of such shareholders in the event shall be to receive the proceeds realised from such sale.

(B) The Board may, in relation to any capitalisation sanctioned under this Bye-law, in its absolute discretion specify that, and in such circumstances and if directed so to do by a member or members entitled to an allotment and distribution credited as fully paid up of unissued shares or debentures in the Company pursuant to such capitalisation, allot and distribute credited as fully paid the issued shares, debentures or other securities to which that member is entitled to such person or persons as that member may nominate by notice in writing to the Company, such notice to be received by the Company at its Head Office not later than the day for which the general meeting of the Company to sanction the capitalisation is convened.

# DIVIDENDS

Power to declare dividends and to make distribution 147. Subject to the Companies Act, the Company in general meeting may by Ordinary Resolution declare dividends in any currency but no dividends shall exceed the amount recommended by the Board. The Company may also by Ordinary Resolution make a distribution to the members out of any contributed surplus (as ascertained in accordance with the Companies Act).

Board's power to 148.(A) The Board may, if it thinks fit, from time to time pay to the pay interim members such interim dividends as appear to the Board to be dividends justified by the profits of the Company and, in particular (but without prejudice to the generality of the foregoing), if at any time the share capital of the Company is divided into different classes, the Board may pay such interim dividends in respect of those shares in the capital of the Company which confer on the holders thereof deferred or non-preferential rights as well as in respect of those shares which confer on the holders thereof preferential rights with regard to dividend, and, provided that if the Board acts bona fide it shall not incur any responsibility to the holders of shares conferring any preference for any loss that they may suffer by reason of the payment of an interim dividend on any shares having deferred or non-preferential rights.

> (B) The Board may also pay half-yearly or at other suitable intervals to be settled by it any dividend which may be payable at a fixed rate if the Board is of the opinion that the profits justify the payment.

Payment of dividend and distribution out of contributed surplus 49. No dividend shall be declared or paid and no distribution of contributed surplus be made otherwise than in accordance with the Companies Act, in particular, no dividend shall be paid or distribution made out of contributed surplus if to do so would render the Company unable to pay its liabilities as they become due or the realisable value of its assets would thereby become less than the aggregate of its liabilities and its issued share capital and share premium accounts. No dividend, unless the same is not paid by the Company when due and payable shall carry interest.

- Scrip dividend 150.(A) Whenever the Board or the Company in general meeting has resolved that a dividend be paid or declared on the shares of the Company, the Board may further resolve:
  - (1) that such dividend be satisfied wholly or in part in the form of an allotment of shares credited as fully paid-up on the basis that the shares so allotted shall be of the same class or classes as the class or classes already held by the allottee, provided that the members entitled thereto will be entitled to elect to receive such dividend (or part thereof) in cash in lieu of such allotment. In such case, the following provisions shall apply:
    - (a) the basis of any such allotment shall be determined by the Board;
    - (b) the Board, after determining the basis of allotment, shall give not less than two (2) weeks' notice in writing to the members of the right of election accorded to them and of the record date related thereto and shall send with or following such notice forms of election and specify the procedure to be followed and the place at which the latest date and time by which duly completed forms of election must be lodged in order to be effective;
    - (c) the right of election may be exercised in respect of the whole or part of that portion of the dividend in respect of which the right of election has been accorded; and
    - (d) the dividend (or that part of the dividend to be satisfied by the allotment of shares as aforesaid) shall not be payable in cash on shares in respect whereof the cash election has not been duly exercised (the "non-elected shares") and in satisfaction thereof shares shall be allotted credited as fully paid-up to the holders of the non-elected shares on the basis of allotment determined as aforesaid and for such purpose the Board shall capitalise and apply out of any part of the

undivided profits of the Company or any part of any sum standing to the credit of the Company's reserve accounts (including, subject to Bye-law 145, sums standing to the credit of any special account, contributed surplus account and share premium account) or to the credit of the profit and loss account or any sum otherwise available for distribution as the Board may determine, a sum equal to the aggregate nominal amount of the shares to be allotted on such basis and apply the same in paying up in full the appropriate number of shares for allotment and distribution to and amongst the holders of the nonelected shares on such basis.

- or
- (2) that the members entitled to such dividend will be entitled to elect to receive an allotment of shares credited as fully paid-up in lieu of the whole or such part of the dividend as the Board may think fit on the basis that the shares so allotted shall be of the same class or classes as the class or classes of shares already held by the allottee. In such cases, the following provisions shall apply:
  - (a) the basis of any such allotment shall be determined by the Board;
  - (b) the Board, after determining the basis of allotment, shall give not less than two (2) weeks' notice in writing to the members of the right of election accorded to them and shall send with or following such notice forms of election and specify the procedure to be followed and the place at which and the latest date and time by which duly completed forms of election must be lodged in order to be effective;
  - (c) the right of election may be exercised in respect of the whole or part of that portion of the dividend in respect of which the right of election has been accorded; and
  - (d) the dividend (or that part of the dividend in respect of which a right of election has been accorded) shall not be payable on shares in respect whereof the share election has been duly exercised (the "elected shares") and in lieu thereof shares shall be allotted credited as fully paid to the holders of the elected shares on the basis of allotment determined as aforesaid and for such

purpose the Board shall capitalise and apply out of any part of the undivided profits of the Company or any part of any sums standing to the credit of any special account, the contributed surplus account, the Company's reserve accounts (including, subject to Bye-law 147, any sums standing to the credit of the share premium account) or to the credit of the profit and loss account or any sum otherwise available for distribution as the Board may determine, a sum equal to the aggregate nominal amount of the shares to be allotted on such basis and apply the same in paying up in full the appropriate number of shares for allotment and distribution to and amongst the holders of the elected shares on such basis.

- (B) The shares allotted pursuant to the provisions of paragraph (A) of this Bye-law shall rank pari passu in all respects with the shares then in issue save only as regards participation:
  - in the relevant dividend (or the right to receive or to elect to receive an allotment of shares in lien thereof as aforesaid); and
  - (2) in any other distributions, bonuses or rights paid, made, declared or announced prior to or contemporaneously of the relevant dividend unless contemporaneously with the announcement by the Board of their proposal to apply the provisions of sub-paragraph (1) or (2) of paragraph (A) of this Bye-law in relation to the relevant dividend or contemporaneously with their announcement of the distribution, bonus or rights in questions, the Board shall specify that the shares to be allotted pursuant to the provisions of paragraph (A) of this Bye-law shall rank for participation in such distribution, bonus or rights.
- (C) The Board may do all acts and things considered necessary or expedient to give effect to any capitalisation pursuant to the provisions of paragraph (A) of this Bye-law with full power to the Board to make such provisions as it thinks fit in the case of shares becoming distributable in fractions (including provisions whereby, in whole or in part, fractional entitlements are aggregated and sold and the net proceeds distributed to those entitled, or are disregarded or rounded up or down or whereby the benefit of fractional entitlements accrues to the Company rather than to the members concerned). The Board may authorise any person to enter into on behalf of all members

interested, an agreement with the Company providing for such capitalisation and matters incidental thereto and any agreement made pursuant to such authority shall be effective and binding on all concerned).

- (D) The Company may upon the recommendation of the Board by Special Resolution resolve in respect of any one particular dividend of the Company that notwithstanding the provisions of paragraph (A) of this Bye-law, a dividend may be satisfied wholly in the form of an allotment of shares credited as fully paid up without offering any right to shareholders to elect to receive such dividend in cash in lieu of such allotment.
- (E) The Board may on any occasion determine that rights of election and the allotment of shares under paragraph (A) of this Bye-law shall not be made available or made to any shareholders with registered addresses in any territory where in the absence of a registration statement or other special formalities the circulation of an offer of such rights of election or the allotment of shares would or might, in the opinion of the Board, be unlawful or impracticable, and in such event the provisions aforesaid shall be read and construed subject to such determination.
- Dividends to be paid in proportion to paid up capital 151. Unless and to the extent that the rights attached to any shares or the terms of issue thereof otherwise provide, all dividends shall (as regards any shares not fully paid throughout the period in respect of which the dividend is paid) be apportioned and paid pro rata according to the amounts paid or credited as paid up on the shares during any portion or portions of the period in respect of which the dividend is paid. No amount paid on a share in advance of calls shall for this purpose be treated as paid on the share.
- Retention of dividends, etc 152.(A) The Board may retain any dividends or other moneys payable on or in respect of a share upon which the Company has a lien, and may apply the same in or towards satisfaction of the debts, liabilities or engagements in respect of which the lien exists.
- Deduction of debts (B) The Board may deduct from any dividend or bonus payable to any member all sums of money (if any) presently payable by him to the Company on account of calls, instalments or otherwise.
- Retention on transmission of shares (C) The Board may retain the dividends or other moneys payable on or in respect of a share in respect of which any person is,

under the provisions as to the transmission of shares hereinbefore contained, entitled to become a member, or which any person is under those provisions entitled to such transfer, until such person shall become a member in respect of such shares.

Dividends and call together 153. Any general meeting sanctioning a dividend may make a call on the members of such amount as the meeting fixes, but so that the call on each member shall not exceed the dividend payable to him, and so that the call shall be made payable at the same time as the dividend, and the dividend may, if so arranged between the Company and the member, be set off against the call.

Effect of transfer 154. A transfer of shares shall not pass the right to any dividend or bonus declared thereon before the registration of transfer of such share.

Receipt for dividends by joint holders of shares 155. If two (2) or more persons are registered as joint holders of any shares, any one of such joint holders may give effectual receipts for any dividends, interim dividends, bonuses or other moneys or property distributable in respect of such shares.

Payment by post 156. Unless otherwise directed by the Board, any dividend, bonus, interest or other sum payable in cash to the holder of shares may be paid by cheque or warrant sent through the post to the registered address of the member entitled, or, in case of joint holders, to the registered address of the holder whose name stands first in the register in respect of the joint holding or to such person and to such address as the holder or joint holders may in writing direct. Every cheque or warrant so sent shall, unless the holder or joint holders otherwise direct, be made payable to the order of the person to whom it is sent, and shall be sent at his or their risk and the payment of any such cheque or warrant shall operate as a good discharge to the Company in respect of the dividend and/or bonus represented thereby, notwithstanding that it may subsequently appear that the same has been stolen or that any endorsement thereon has been forged.

Unclaimed dividend 157.(A) The Company may cease sending dividend warrants by post to a member if dividend warrants sent through the post in a prepaid letter addressed to the member at his registered address or otherwise the last known address given by the member are returned undelivered or are left uncashed on two consecutive occasions.

- (B) All dividends and distributions unclaimed for one year after having been declared may be invested or otherwise made use of (including by a sale of the relevant distribution) by the Board for the benefit of the Company until claimed but the Company shall not be constituted a trustee in respect thereof. All dividends and distributions unclaimed for six (6) years after having been declared may be forfeited by the Board and shall revert to the Company and after such forfeiture no member or other person shall have any right to any such dividend or bonus.
- Record date for 158. Any resolution declaring a dividend on share of any class, dividend whether a resolution of the Company in general meeting or a resolution of the Board, may specify that the same shall be payable or distributable to the persons registered as the holder of such shares at the close of business on a particular date, notwithstanding that it may be a date prior to that on which the resolution is passed, and thereupon the dividend shall be payable or distributable to them in accordance with their respective holdings so registered, but without prejudice to the rights inter se in respect of such dividend of transferors and transferees of any such shares. The provisions of this Bye-law shall mutatis mutandis apply to bonuses, capitalisation issues, distributions of realised capital profits or offers or grants made by the Company to the members.
  - 159. Whenever the Board or the Company in general meetings has resolved that a dividend be paid or declared, the Board may further resolve that such dividend be satisfied wholly or in part by the distribution of specific assets of any kind and in particular of paid up shares, debentures or warrants to subscribe for securities of the Company or any other company, or in any one or more of such ways, with or without offering any rights to shareholders to elect to receive such dividend in cash, and where any difficulty arises in regard to the distribution the Board may settle the same as it thinks expedient, and in particular may disregard fractional entitlements or round the same up or down, and may fix the value for distribution of such specific assets, or any part thereof, and may determine that cash payments shall be made to any members upon the footing of the value so fixed in order to adjust the rights of all parties and may determine that fractional entitlements shall be aggregated and sold and the benefit shall accrue to the Company rather than to the members concerned, and may vest any such specific assets in trustees as may seem expedient to the Board and may appoint any person to sign any requisite instruments of transfer

and other documents on behalf of the persons entitled to the dividend and such appointment shall be effective. Where requisite, the Board may appoint any person to sign a contract on behalf of the persons entitled to the dividend and such appointment shall be effective. Where requisite, the Board may appoint any person to sign a contract on behalf of the persons entitled to the dividend and such appointment shall be effective. The Board may resolve that no such assets shall be made available or made to shareholders with registered addresses in any particular territory or territories being a territory or territories where, in the absence of a registration statement or other special formalities, this would or might, in the opinion of the Board, be unlawful or impracticable and in such event the only entitlement of the shareholders aforesaid shall be to receive cash payments as aforesaid. Shareholders affected as a result of the foregoing provision shall not be or be deemed to be, a separate class of shareholders for any purpose whatsoever.

## DISTRIBUTION OF REALISED CAPITAL PROFITS

Distribution of 160. The Company in general meeting may at any time and from realised capital time to time resolve that any surplus moneys in the hands of the profits Company representing capital profits arising from moneys received or recovered in respect of or arising from the realisation of any capital assets of the Company or any investments representing the same and not required for the payment or provisions of any fixed preferential dividend instead of being applied in the purchase of any other capital assets or for other capital purposes be distributed amongst the ordinary shareholders on the footing that they receive the same as capital and in the shares and proportions in which they would have been entitled to receive the same if it had been distributed by way of dividend, provided that no such profits as aforesaid shall be so distributed if there are reasonable grounds for believing that (a) the Company is, or would after the payment be, unable to pay its liabilities as they become due; or (b) the realisable value of the Company's assets would thereby be less than the aggregate of its liabilities and its issued share capital and share premium accounts.

## ANNUAL RETURNS

Annual Returns 161. The Board shall make the requisite annual or other returns or filings as may be required to be made in accordance with the Companies Act.

# ACCOUNTS

- Accounts to be kept 162. The Board shall cause true accounts to be kept of the sums of money received and expended by the Company and the matters in respect of which such receipts and expenditure take place; and of the property, assets, credits and liabilities of the Company and all other matters required by the provisions of the Companies Act or necessary to give a true and fair view of the state of the Company's affairs and to show and explain its transactions.
- Where accounts to<br/>be kept163.The books of account shall be kept at the Head Office or at such<br/>other place or places as the Board thinks fit and shall always be<br/>open to the inspection of the Directors provided that such<br/>records as are required by the provisions of the Companies Act<br/>shall also be kept at the Registered Office.
- Inspection by members 164. No member (not being a Director) or other person shall have any right to inspect any account or book or document of the Company except as conferred by the provisions of the Companies Act or ordered by a court of competent jurisdiction or authorised by the Board or by the Company in general meeting.
- Annual profit and 165.(A) The Board shall from time to time cause to be prepared and laid loss account and before the Company at its annual and general meeting such balance sheet profit and loss accounts, balance sheets, group accounts (if any) and reports as are required by the provisions of the Companies Act. The Auditors shall make a report to the members, in accordance with generally accepted auditing standards, on the accounts examined by them, and on every balance sheet, every profit and loss account and all group accounts laid before the Company in general meeting during their tenure of office. The Auditors' report shall be read before the Company in general meeting and open to inspection by any member. The generally accepted auditing standards referred to herein may be those of a country or jurisdiction other than Bermuda. If so, the financial statements and the report of the Auditors should disclose this fact and name such country or jurisdiction.

Annual report of Directors and balance sheet to be sent to members

- Subject to paragraph (C) below, every balance sheet of the (B) Company shall be approved by the Board and signed on behalf of the Board by two Directors, and a copy of every balance sheet (including every document required by law to be comprised therein or attached or annexed thereto) and profit and loss account which is to be laid before the Company in its annual general meeting, together with a copy of the Director's report and a copy of the Auditors' report shall, not less than twenty-one (21) days before the date of the meeting, be sent to every member of, and every holder of debentures of, the Company and every other person entitled to receive notices of general meetings of the Company under the provisions of the Companies Act or these Bye-laws, provided that this Bye-law shall not require a copy of those documents to be sent to any person of whose address the Company is not aware or to more than one of the joint holders of any shares or debentures. If all or any of the shares or debentures of the Company are for the time being (with the consent of the Company) listed or dealt in on any stock exchange, there shall be forwarded to the appropriate officers of such stock exchange such number of copies of such documents as may for the time being be required under its regulations or practice.
- (C) The Company may send summarized financial statements to members of the Company who has, in accordance with the Statutes and any applicable rules prescribed by the Stock Exchange, consented and elected to receive summarized financial statements instead of the full financial statements. The summarized financial statements must be accompanied by an auditor's report and notice informing the member how to notify the Company that he elects to receive the full financial statements. The summarized financial statements, notice and auditor's report must be sent not less than twenty-one days before the general meeting to those members that consented and elected to receive the summarized financial statements. (as amended by special resolution passed on 28<sup>th</sup> August, 2007)
- (D) Subject to Section 88 of the Companies Act, the Company shall send the full financial statements to a member within seven days of receipt of the member's election to receive the full financial statements.

## AUDITORS

Appointment of Auditors 166.(A) Auditors shall be appointed and the terms and tenure of such appointment and their duties at all times regulated in accordance with the provisions of the Companies Act.

- (B) Subject to Section 88 of the Companies Act, members shall at each annual general meeting appoint one or more Auditors by Ordinary Resolution to hold office until the conclusion of the next annual general meeting, but if an appointment is not made, the Auditor or Auditors in office shall continue in office until a successor is appointed. A Director, officer or employee of the Company or of any of its subsidiaries or a partner, officer or employee of any such Director, officer or employee shall not be capable of being appointed Auditor of the Company. Subject as otherwise provided by the Companies Act, the remuneration of the Auditor or Auditors shall be fixed by the members in the annual general meeting by Ordinary Resolution, by other body that is independent of the Board or, unless prohibited by the rules of the Stock Exchange, in the manner specified in the members' resolution. Subject to the compliance with the rules of the Stock Exchange, the Board may fill any casual vacancy in the office of Auditor, but while any such vacancy continues the surviving or continuing Auditor or Auditors (if any) may act. Subject to the compliance with the rules of the Stock Exchange, the remuneration of any Auditor appointed by the Board shall fill the vacancy under this Bye-law may be fixed by the Board. Subject to the compliance with the rules of the Stock Exchange, an Auditor appointed by the Board shall hold office until the next following annual general meeting of the Company and shall then be subject to appointment by the members at such remuneration to be determined by the members under this Bye-law.
- (C) The members may, at any general meeting convened and held in accordance with these Bye-laws, by a resolution passed by a majority of at least two-thirds of votes cast by such members as, being entitled so to do, vote in person or, in the case of such members as are corporations, by their respective duly authorised representative or, where proxies are allowed, by proxy, remove the Auditor at any time before the expiration of his term of office and shall by Ordinary Resolution at that meeting appoint another Auditor in his stead for the remainder of his term.

Auditors to have 167. right of access to books and accounts

The Auditor or Auditors of the Company shall have a right of access at all times to the books and accounts and vouchers of the Company and shall be entitled to require from the Directors and officers of the Company such information as may be necessary for the performance accounts of his or their duties.

Appointment of an 168. A person other than a retiring Auditor shall not be capable of auditor other than a being appointed Auditor at an annual general meeting unless retiring auditor notice of an intention to nominate that person to the office of Auditor has been given to the Company not less than fourteen (14) days before the annual general meeting, and the Company shall send a copy of any such notice to the retiring Auditor and shall give notice thereof to the members not less than seven (7) days before the annual general meeting provided that the above requirements may be waived by notice in writing by the retiring Auditor to the Secretary provided that if after a notice of the intention to nominate an Auditor has been so given an annual general meeting is called for a date fourteen (14) days or less after that notice has been given, the notice, though not given within the time required by this provision, shall be deemed to have been properly given for the purposes thereof, and the notice to be sent or given by the Company may instead of being sent or given within the time required by this provision be sent or given at the same time as the notice of the annual general meeting.

Defect in appointment of auditors 169. Subject to the provision of the Companies Act, all acts done by any person acting as an Auditor shall, as regards all persons dealing in good faith with the Company, be valid, notwithstanding that there was some defect in his appointment or that he was at the time of his appointment not qualified for appointment or subsequently became disqualified.

# NOTICES

- Service of notices 170.(A) (1) Except where otherwise expressly stated, any notice to be given to or by any person pursuant to these Bye-laws shall be in writing or, to the extent permitted by the Statutes and any applicable rules prescribed by the Stock Exchange from time to time and subject to this Bye-law, contained in an electronic communication. A notice calling a meeting of the Directors need not be in writing.
  - (2) Any notice or document (including any "corporate communication" within the meaning ascribed thereto under

the rules of the Stock Exchange), whether or not, to be given or issued under these Bye-laws from the Company shall be in writing or by cable, telex or facsimile transmission message or other form of electronic transmission or electronic communication and any such notice and document may be given or issued by following means:

- (a) by serving it personally on the relevant person;
- (b) by sending it through the post in a prepaid envelope addressed to such member at his registered address as appearing in the Register or at any other address supplied by him to the Company for the purpose;
- (c) by delivering or leaving it at such address as aforesaid;
- (d) by placing an advertisement in appointed newspapers (as defined in the Companies Act) or in newspapers published daily and circulating generally in the territory of and in accordance with the requirements of the Stock Exchange;
- (e) by sending or transmitting it as an electronic communication to the relevant person at such electronic address as he may provide under Bye-law 170.(B)(5), subject to the Company complying with the Statutes and any other applicable laws, rules and regulations from time to time in force with regard to any requirements for the obtaining of consent (or deemed consent) from such person;
- (f) by publishing it on the Company's website or to which the relevant person may have access, subject to the Company complying with the Statutes and any other applicable laws, rules and regulations from time to time in force with regard to any requirements for the obtaining of consent (or deemed consent) from such person and/or giving notification to any such person stating that the notice, document or publication is available on the Company's computer network website; or
- (g) by sending or otherwise making it available to such person through such other means to the extent

permitted by and in accordance with the Statutes and other applicable laws, rules and regulations.

- (3) Any such notice or document may be served or delivered by the Company by reference to the register as it stands at any time not more than fifteen days before the date of service or delivery. No change in the register after that time shall invalidate that service or delivery. Where any notice or document is served or delivered to any person in respect of a share in accordance with these Bye-laws, no person deriving any title or interest in that share shall be entitled to any further service or delivery of that notice or document.
- (B) (1) Any notice or document required to be sent to or served upon the Company, or upon any officer of the Company, may be sent or served by leaving the same or sending it through the post in a prepaid envelope or wrapper addressed to the Company or to such officer at the Company's Head Office or Registered Office.
  - (2) The Directors may from time to time specify the form and manner in which a notice may be given to the Company by electronic means, including one or more addresses for the receipt of an electronic communication, and may prescribe such procedures as they think fit for verifying the authenticity or integrity of any such electronic communication. Any notice may be given to the Company by electronic means only if it is given in accordance with the requirements specified by the Directors.
  - (3) In the case of joint holders of a share all notices shall be given to that one of the joint holders whose name stands first in the Register and notice so given shall be deemed a sufficient service on or delivery to all the joint holders.
  - (4) Every person who, by operation of law, transfer, transmission, or other means whatsoever, shall become entitled to any share, shall be bound by every notice in respect of such share, which, previously to his name and address (including electronic address) being entered in the Register as the registered holder of such share, shall have

been duly given to the person from whom he derives title to such share.

- (5) Every member or a person who is entitled to receive notice from the Company under the provisions of the Statutes or these Bye-laws may register with the Company an electronic address to which notices can be served upon him.
- (6) Subject to any applicable laws, rules and regulations and the terms of these Bye-laws, any notice, document or publication, including but not limited to the documents referred to in Bye-laws 165.(B), 165.(C) and 170.(A) may be given to a member either in the English language only or in both the English language and the Chinese language, subject to due compliance with all applicable Statutes, rules and regulations.
- (7) Any notice or other document:
  - (a) if published on the Company's website, shall be deemed to have been served on the day on which the notice, document or publication first so appears on the Company's website to which the relevant person may have access or the day on which the notice of availability is deemed to have been served or delivered to such person under these Bye-laws, whichever is later;
  - (b) if served or delivered in any other manner contemplated by these Bye-laws, shall be deemed to have been served or delivered at the time of personal service or delivery or, as the case may be, at the time of the relevant despatch or transmission; and in proving such service or delivery a certificate in writing signed by the Secretary or other officer of the Company or other person appointed by the Board as to the fact and time of such service, delivery, despatch or transmission

# shall be conclusive evidence thereof; and

- (c) if published as an advertisement in a newspaper or other publication permitted under these Bye-laws, shall be deemed to have been served on the day on which the advertisement first so appears.
- Members outside 171. Any member whose registered address is outside the Relevant the Relevant Territory may notify the Company in writing of an address in Territory the Relevant Territory which for the purpose of service of notice or documents shall be deemed to be his registered address. Where the registered address of the member is outside the Relevant Territory, notice, if given through the post, shall be sent by prepaid airmail letter. A member who has no registered address shall be deemed to have received any notice which shall have been displayed at the Head Office and shall have remained there for the space of twenty-four (24) hours and such notice shall be deemed to have been received by such member on the day following that on which it shall have been first so displayed.
- When notice by 172. Any notice or other document, if sent by mail, postage prepaid, post deemed to be shall be deemed to have been served or delivered on the day served following that on which the letter, envelope, or wrapper containing the same is put into the post. In proving such service it shall be sufficient to prove that the letter, envelope or wrapper containing the notice or document was properly addressed and put into the post as prepaid mail. Any notice or document not sent by post but left by the Company at a registered address shall be deemed to have been served or delivered on the day it was so left. Any notice or document, if sent by electronic means (including through any relevant system), shall be deemed to be have been given on the day following that on which the electronic communication was sent by or on behalf of the Company. Any notice or document served or delivered by the Company by any other means authorised in writing by the member concerned shall be deemed to have been served when the Company has carried out the action it has been authorised to take for that purpose. Any notice or other document published by way of advertisement or on a computer network shall be deemed to have been served or delivered on the day it was so published on the website.

Service of notice to persons entitled on death, mental Any notice or document may be given by the Company to the person entitled to a share in consequence of the death, mental

disorder or bankruptcy of member		disorder or bankruptcy of a member by sending it through the post left at in a prepaid letter addressed to him by name, or by the title of representative of the deceased, or trustee of the bankrupt, or by any like description, at the address, if any, within the Relevant Territory supplied for the purpose by the person claiming to be so entitled, or (until such an address has been so supplied) by giving the notice in any manner in which the same might have been given if the death, mental disorder or bankruptcy had not occurred.
Transferee to be bound by prior notices	174.	Any person who, by operation of law, transfer, transmission or other means whatsoever, shall become entitled to any share, shall be bound by every notice in respect of such share, which, prior to his name and address being entered on the register as the registered holder of such share shall have been duly given to the person from whom he derives his title to such share.
Notice valid though member deceased or bankruptcy	175.	Any notice or document delivered or sent by post or left at the registered address of any member in pursuant to these Bye- laws, shall notwithstanding that such member be then deceased or bankrupt and whether or not the Company has notice of his death or bankruptcy be deemed to have been duly served in respect of any registered shares whether held solely or jointly with other persons by such member until some other person be registered in his stead as the holder or joint holder thereof, and such service shall for the purposes of Bye-laws be deemed a sufficient service of such notice or document on his personal representatives and all persons (if any) jointly interested with him in any such shares.
How notice be signed	176.	The signature to any notice to be given by the Company may be written or printed.
Notice in newspapers	177.	All notices required to be given by advertisement shall be published in the Newspapers.
Reckoning of notice	178.	In reckoning the period for any notice given under these Bye- laws, the day on which notice is served, or deemed to be served, and the day for which such notice is given shall be excluded.

#### **INFORMATION**

- Member not entitled to information 179. No member (not being a Director) shall be entitled to require discovery of or any information respecting any detail of the Company's trading or any matter which is or may be in the nature of a trade secret or secret process which may relate to the conduct of the business of the Company and which in the opinion of the Board it would not be in the interests of the members or the Company to communicate to the public.
- Directors entitled 180. The Directors shall be entitled to release or disclose any information in their possession, custody or control regarding the Company or its affairs or any of its members including, without limitation, information contained in the register of members and transfer books of the Company.

#### WINDING UP

- Modes of winding 181. A resolution that the Company be wound up by the court or be wound up voluntarily shall be a Special Resolution.
- Distribution of assets in winding up 182. If the Company shall be wound up, the surplus assets remaining after payment to all creditors shall be divided among the members in proportion to the capital paid up on the shares held by them respectively, and if such surplus assets shall be insufficient to repay the whole of the paid up capital, they shall be distributed so that, as nearly as may be, the losses shall be borne by the members in proportion to the capital paid up on the shares held by them respectively, but all subject to the rights of any shares which may be issued on special terms and conditions.

Assets may be If the Company shall be wound up (whether the liquidation is 183. distributed in voluntary or by the court) the liquidator may, with the sanction specie of a Special Resolution and any other sanction required by the Companies Act, divide among the members in specie or kind the whole or any part of the assets of the Company whether the assets shall consist of property of one kind or shall consist of properties of different kinds and the liquidator may, for such purpose, set such value as he deems fair upon any one or more class or classes of property to be divided as aforesaid and may determine how such division shall be carried out as between the members or different classes of members and the members within each class. The liquidator may, with the like sanction, vest any part of the assets in trustees upon such trusts for the benefit of members as the liquidator, with the like sanction,

shall think fit, but so that no member shall be compelled to accept any shares or other assets upon which there is a liability.

Service of process In the event of a winding-up of the Company, every member of 184. the Company who is not for the time being in the Relevant Territory shall be bound, within fourteen (14) days after the passing of an effective resolution to wind up the Company voluntarily, or the making of an order for the winding-up of the Company, to serve notice in writing on the Company appointing some person resident in the Relevant Territory and stating that person's full name, address and occupation upon whom all summonses, notices, process, order and judgments in relation to or under the winding-up of the Company may be served, and in default of such nomination the liquidator of the Company shall be at liberty on behalf of such member to appoint some such person, and service upon any such appointee, whether appointed by the member or the liquidator, shall be deemed to be good personal service on such member for all purposes, and, where the liquidator makes any such appointment, he shall with all convenient speed give notice thereof to such member by advertisement as he shall deem appropriate or by a registered letter sent through the post and addressed to such member at his address as mentioned in the Register, and such notice shall be deemed to be service on the day following that on which the advertisement appears or the letter is posted.

# **INDEMNITY**

Indemnity of Save and except so far as the provisions of this Bye-law shall 185.(A) officers be avoided by any provisions of the Companies Act, every Director, alternate Director or other officer and the Auditor or Auditors of the Company shall be indemnified out of the assets of the Company against all costs, charges, expenses, losses and liabilities which he may sustain or incur in or about the execution of his office or otherwise in relation thereto and in particular and without prejudice to the generality of the foregoing, every Director, alternate Director, attorney, manager and other officer or servant of the Company shall be indemnified by the Company against, and it shall be the duty of the Board out of the funds of the Company to pay all costs, losses, expenses and damages which any such Director, attorney, manager, officer or servant may incur or become liable for by reason of any act done, concurred in or omitted in or about the execution of their duty or supposed duty in their respective offices on trusts except such (if any) as they shall incur or sustain through their own wilful neglect or wilful default, fraud and dishonesty respectively and the amount for which such indemnity is provided shall immediately attach as a lien on the property of the Company, and have priority as against the members over all other claims. No Director, alternate Director, manager or other officer of the Company shall be liable for the acts, receipts, neglects or defaults of any other Director, alternate Director, manager or other officer of the Company or for any losses or expenses happening to the Company through the insufficiency or deficiency of title to any property acquired by order of the Board for or on behalf of the Company, or for the insufficiency or deficiency of any security in or upon which any of the moneys of the Company shall be invested, or for any loss or damage arising from the bankruptcy, insolvency or tortious act of any person with whom any moneys, securities or effects shall be deposited or for any loss occasioned by any error of judgement, omission, default or oversight on their part, or for any loss, damage or misfortune whatever which shall happen in the execution of the duties of office or in relation thereto, unless the same shall have happened through their own wilful neglect, wilful default, fraud or dishonesty.

(B) If any Director or other person shall become personally liable for the payment of any sum primarily due from the Company, the Directors may execute or cause to be executed any mortgage, charge, or security over or affecting the whole or any part of the assets of the Company by way of indemnity to secure the Director or person so becoming liable as aforesaid from any loss in respect of such liability.

# FINANCIAL YEAR

Fiscal year 186. The fiscal year of the Company shall be prescribed by the Board and may, from time to time, be changed by it.

# AMENDMENT TO MEMORANDUM OF ASSOCIATION AND BYE-LAWS

Amendment to<br/>Memorandum of<br/>Association and187.Without prejudice to the requirements of the Companies Act,<br/>a Special Resolution shall be required to alter the provisions<br/>of the Memorandum of Association, to approve any<br/>amendment to these Bye-laws or to change the name of the<br/>Company.

#### **RESIDENT REPRESENTATIVE**

Resident 188. For so long as the Company does not have a quorum of Representative Directors ordinarily resident in Bermuda, the Company shall in accordance with the Companies Act appoint and maintain a Resident Representative ordinarily resident in Bermuda, to act on its behalf in Bermuda and to maintain all such records in Bermuda and to make all necessary filings with the Ministry of Finance and Registrar of Companies in Bermuda as may be required by the Companies Act. The Company shall provide the Resident Representative with such documents and information as the Resident Representative may require in order to be able to comply with the provisions of the Companies Act. The Resident Representative shall be entitled to have notice of, attend and be heard at any Director's meetings or general meetings of the Company.

# SUBSCRIPTION RIGHT RESERVE

Subscription Right 189. The following provisions shall have effect to the extent that they are not prohibited by and are in compliance with the Companies Act:

- (A) If during the period while any of the rights attached to any warrants issued by the Company to subscribe for shares remain to be exercisable, the Company does any act or engages in any transaction which, as a result of any adjustments to the subscription price in accordance with the provisions applicable under the terms and conditions of the warrants, would reduce the subscription price therefor to below the par value of a share, then the following provision shall apply:
  - (1) as from the date of such act or transaction the Company shall establish and thereafter (subject as provided in this Bye-law) maintain in accordance with the provisions of this Bye-law a reserve (the "Subscription Right Reserve") which may be established and maintained by setting aside such amount out of the profits and reserves of the Company (including so far as it permitted by the Companies Act out of the share premium account of the Company) as may from time to time be determined by the Directors provided that the amount of which shall at no time be less than the sum which for the time being would be required to be capitalised and applied in paying up in full the nominal amount of the additional shares required to be issued and allotted credited as fully paid pursuant to

sub-paragraph (3) below on the exercise in full of all the subscription rights outstanding and shall apply the Subscription Rights Reserve in paying up in full such additional shares as and when the same are allotted;

- (2) the Subscription Right Reserve shall not be used for any purpose other than that specified above unless and until all other available reserves of the Company have been so used and will then only be used to make good losses of the Company if and so far as is required by law;
- (3) upon the exercise of all or any of the subscription rights represented by any warrant, the relevant subscription right shall be exercisable in respect of a nominal amount of shares equal to the amount in cash which the holder of such warrant is required to pay on exercise of the subscription rights represented thereby or (as the case may be the relevant proportion thereof which is the same as the proportion of the subscription rights then being exercised) (with any fractional entitlement being dealt with in accordance with paragraph (C) below) and, in addition, there shall be allotted in respect of the exercise of such subscription rights, to the holder of the warrant exceeding such subscription rights, credited as fully paid, additional shares of a nominal amount which is equal to the difference between:
  - (a) the said amount in cash which the holder of such warrant is required to pay on exercise of the subscription rights represented thereby or, as the case may be, the proportion thereof which is the same as the proportion of the subscription rights then being exercised; and
  - (b) the nominal amount of shares in respect of which such subscription rights would have been exercisable, having regard to the provisions applicable under the terms and conditions of the warrants, had it been possible for such subscription rights to represent the right to subscribe for shares at less than their nominal value; and immediately upon such exercise so much of the sum standing to the credit of the Subscription Right Reserve as is required to pay up in full the nominal amount of such additional shares and the relevant number of shares shall forthwith be allotted, credited as fully

paid up, to the holder of the warrant exercising such subscription rights; and

- (c) if upon the exercise of the subscription rights represented by any warrant the amount standing to the credit of the Subscription Right Reserve is not sufficient to pay in full the nominal amount of such additional shares equal to such difference as aforesaid to which the holder of the warrant exercising such subscription rights is entitled, the Board shall apply any profits or reserve then or thereafter becoming available (including, to the extent permitted by the Companies Act, the share premium account) for such purpose until the nominal amount of such additional shares is paid up in full and the relevant number of shares are allotted as aforesaid and until such time no dividend or other distributions shall be paid or made on the shares. Pending such payment and allotment, the holder of the warrant exercising such subscription rights shall be issued by the Company with a certificate evidencing his right to the allotment of the additional shares which have not been allotted to him. The rights represented by any such certificate shall be in registered form and shall be transferable in whole or in part in units of one share in the like manner as the shares for the time being are transferable, and the Company shall make such arrangements in relation to the maintenance of a register therefor and other matters in relation thereto as the Board may determine as appropriate, and adequate particulars thereof shall be made known to each relevant holder of the warrant exercising such subscription rights upon the issue of such certificate.
- (B) Shares allotted pursuant to the provisions of this Bye-law shall rank pari passu in all respects with the other shares allotted on the relevant exercise of the subscription rights represented by the warrant concerned.
- (C) Notwithstanding anything contained in paragraph (A) of this Bye-law, no fraction of any share shall be allotted on the exercise of the subscription rights and so that whether any (and, if so, what) fraction of a share arises shall be determined according to the provisions applicable under the terms and

conditions of the warrants or, in the absence of any such provisions, pursuant to paragraph (D) of this Bye-law.

(D) A certificate or report by the Auditors as to whether or not at any time the Subscription Rights Reserve is required to be established and maintained and if so the amount thereof which is so required to be established and maintained, as to the purposes for which the Subscription Right Reserve has been used, as to the extent to which it has been used to make good losses of the Company, as to the additional nominal amount of shares required to be allotted to holders of warrants exercising any subscription rights credited as fully paid up and as to any other matter concerning the Subscription Right Reserve shall (in the absence of manifest error) be conclusive and binding upon the Company and all warrantholders and shareholders and all persons claiming through or under them respectively.
