- Option 4: to receive by mail both the printed Chinese and English versions of all Corporate Communications.

If the Company does not receive the duly completed Reply Form or receive a response indicating any objection from you by 30 September 2022, you will be deemed to have consented to receiving the Website Version for all the future Corporate Communications and a notification letter informing you of the posting of the Corporate Communications on the website of the Company will be sent to you in future as and when they are published.

You are entitled to change the choice of language and/or means of receipt of the Corporate Communications at any time by notice in writing to the HK Share Registrar or by email to the Company at **kerryprops@hk.tricorglobal.com**. If you have elected (or are deemed to have consented) to receive the Website Version of future Corporate Communications, and if for any reason, you have difficulty in accessing the Corporate Communications via the website of the Company, the Company or the HK Share Registrar will upon your request, promptly send the requested Corporate Communications to you in printed form free of charge.
