Remarks: Reference is made to the announcement of Suzhou Basecare Medical Corporation Limited (the "Company") dated September 9, 2022. As at August 31, 2022, the opening balance of the total number of issued shares of the Company was 273,526,000 which comprised 80,933,418 H shares, 183,181,817 domestic shares and 9,410,765 unlisted foreign shares. Following the Conversion and Listing, the H shares increased by 1,780,417 shares, while unlisted foreign shares decreased by 1,780,417 shares. The total number of issued shares of the Company after the Conversion and Listing remains unchanged.

We hereby confirm to the best knowledge, information and belief that, in relation to each issue of securities as set out in Section I, it has been duly authorised by the board of directors of the listed issuer and, insofar as applicable:

- (i) all money due to the listed issuer in respect of the issue of securities has been received by it;

8. *The closing balance date is the date of the last relevant event being disclosed.*

9. *Items (i) to (viii) are suggested forms of confirmation which may be amended to meet individual cases.*

10. *“Identical” means in this context:*

- *the securities are of the same nominal value with the same amount called up or paid up;*
- *they are entitled to dividend/interest at the same rate and for the same period, so that at the next ensuing distribution, the dividend/interest payable per unit will amount to exactly the same sum (gross and net); and*
- *they carry the same rights as to unrestricted transfer, attendance and voting at meetings and rank pari passu in all other respects.*

11. *SEHK refers to Stock Exchange of Hong Kong.*
