If we do not receive the duly completed and signed Reply Form or receive a response indicating any objection from you within 28 days from the date of this letter, you will be deemed to have consented to receiving future Corporate Communication in Website Version only. A printed notification letter of the publication of the Corporate Communication on Prosperity REIT's website will be sent to you by post.

If you choose to receive future Corporate Communication in printed form, Prosperity REIT will send the selected language version(s) of the Corporate Communication to you unless and until you notify Prosperity REIT c/o the Unit Registrar by reasonable prior notice in writing, either by post or by sending an email to [prosperityreit.ecom@computershare.com.hk](mailto:prosperityreit.ecom@computershare.com.hk), that you wish to receive future Corporate Communication in the other language or both languages, or by electronic means through Prosperity REIT's website (i.e. the Website Version). You have the right at any time by reasonable prior notice in writing to the Unit Registrar, either by post or by sending an email to [prosperityreit.ecom@computershare.com.hk](mailto:prosperityreit.ecom@computershare.com.hk), specifying your name, address and request, change the choice of means of receipt and/or language of future Corporate Communication.
