After taking up the accounting entry relating to final dividend for the year of 2021, the figures (amount expressed in RMB'000) as at 30 June 2022 under "Interim Condensed Consolidated Statement of Financial Position" on pages 4 and 5 of the Interim Results Announcement should be read as: "Other payables and accruals" of <u>4,643,072</u>, "Total current liabilities" of <u>6,375,669</u>, "Net current assets" of <u>12,828,671</u>, "Total assets less current liabilities" of <u>25,570,049</u>, "Net assets" of <u>23,380,708</u>, "Reserves" of <u>21,883,165</u>, "Total equity attributable to owners of the parent" of <u>21,883,166</u>, and "Total equity" of <u>23,380,708</u>, respectively.

As a result of the above changes, corresponding changes are made to the notes to the interim condensed consolidated interim financial information for the six months ended 30 June 2022 and certain other parts of the Interim Results Announcement. During the six months ended 30 June 2022, the Company declared a final dividend of HK\$0.1733 per ordinary share, equivalent to a total of approximately <u>RMB1.32 billion</u> for the year ended 31 December 2021 to its shareholders.

The contents under "Capital Structure" of page 24 of the Interim Results Announcement:

As at 30 June 2022, the Group had net assets of <u>RMB23,380.7 million</u>, comprising current assets of RMB19,204.3 million, non-current assets of RMB12,741.4 million, current liabilities of <u>RMB6,375.7 million</u> and non-current liabilities of RMB2,189.3 million.

The Group's gearing ratio was calculated by net debt divided by the capital plus net debt. Net debt is calculated as interest-bearing bank and other borrowings, as shown in the consolidated statements of financial position less cash and bank balances, time deposits, restricted cash and long-term bank deposits. Total capital is calculated as equity holders' funds (i.e. total equity attributable to equity holder of the Company), as shown in the consolidated statements of financial position. The Group's gearing ratio was (0.42) as at 31 December 2021 and (0.45) as at 30 June 2022.

Save for the above adjustments, all information and contents set out in the Interim Results Announcement shall remain unchanged. The interim condensed consolidated financial information of the Group for the six months ended 30 June 2022 with the above adjustments will be incorporated and disclosed in the Company's interim report for the six months ended 30 June 2022, which will be published in due course in compliance with the Listing Rules.
