If you attend the AGM online, you will be able to view a live webcast of the AGM, cast your vote on the resolution in real time and submit online questions. The Online Platform will be open for you to log in approximately 30 minutes prior to the commencement of the AGM. For details of the arrangement, please refer to the circular dated 5 October 2022 in relation to general mandate to buy back units and notice of AGM of Sunlight REIT.

Your login details to access the Online Platform (including the username and password) are printed on the top right corner of this letter. Please refer to the Online Platform User Guide posted on Sunlight REIT's website at <u>www.sunlightreit.com</u>. You are responsible for keeping the login details in safe custody for use at the AGM and should not disclose them to anyone else.

#### Election of Means of Receipt and Language of Corporate Communications

If you choose to access Corporate Communications by electronic means, we shall send you a notification to your email address (provided in the reply form) on the date when a Corporate Communication is published. If for any reason you have difficulty in gaining access to the relevant documents, we shall promptly send printed version of the same to you free of charge upon request.

You are entitled to change your choice at any time by reasonable notice in writing to the Unit Registrar either by post, by email or by fax.
