If you wish to vote against any resolution, please put a tick in the box marked “Against” or insert the number of Domestic Shares held by you. If you wish to vote abstention on any resolution, please put a tick in the box marked “Abstain” or insert the number of Domestic Shares held by you. If no direction is given, your proxy shall vote at his/her own discretion. The Domestic Shares abstained will be counted in the calculation of the required majority.

This form of proxy must be signed by you or your attorney duly authorized in writing or, in the case of a corporation, must be either executed under its common seal or under the hand of its director or a representative duly authorized in writing. In case of joint Domestic Shareholders, this form of proxy may be signed by any of such joint Domestic Shareholders.
7. To be valid, this form of proxy and, if such proxy is signed by a person on behalf of the appointer pursuant to a power of attorney or other authority, a notarially certified copy of that power of attorney or other authority must be delivered to the office of the board of directors of the Bank at Zhongke Golden Tower, No. 23 Shangwu Waihuan Road, Zhengdong New District, Zhengzhou, Henan Province, the PRC not less than 24 hours before the time for the holding of the Domestic Share Class Meeting or any adjournment thereof.

In case of joint Domestic Shareholders, any one of such Domestic Shareholders may vote at the Domestic Share Class Meeting of either in person or by proxy in respect of such Domestic Shares as if he/she was solely entitled thereto. However, if more than one of such joint Domestic Shareholders are present at the Domestic Share Class Meeting in person or by proxy, the vote of the person (in person or by a proxy) whose name appears first in the register of members of the Bank will be accepted as the sole and exclusive vote of the joint Domestic Shareholders.
9. You are reminded that completion and return of the form of proxy will not preclude you from attending and voting in person at the Domestic Share Class Meeting or any adjournment thereof if you so wish.
