UNAUDITED OPERATING STATISTICS FOR THE NINE MONTHS ENDED 30 SEPTEMBER 2022

The board of directors (the “**Board**”) of Sunkwan Properties Group Limited (the “**Company**”, together with its subsidiaries, collectively the “**Group**”) is pleased to announce that the cumulative contracted sales of the Group, together with the joint ventures and associates, for the nine months ended 30 September 2022, were approximately RMB7.32 billion, and the contracted sales area was approximately 574,584 square meters. The average contracted sales price for the nine months ended 30 September 2022 was approximately RMB12,746 per square meter.
