### **ANNOUNCEMENT UNAUDITED OPERATING DATA FOR SEPTEMBER 2022**

This announcement is made by CENTRAL CHINA MANAGEMENT COMPANY LIMITED (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to the Inside Information Provisions (as defined under the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”)) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong) and Rule 13.09(2)(a) of the Listing Rules.

The board (the “**Board**”) of directors (the “**Directors**” and each a “**Director**”) of the Company hereby announces certain unaudited operating data of the Group for the nine months ended 30 September 2022 as follows:

#### **KEY OPERATING METRICS**

In September 2022, the Group had seven newly contracted projects, with newly contracted gross floor area (“**GFA**”) of 635,706 square metres (“**sq. m.**”).

For the nine months ended 30 September 2022, the Group had 18 new contracted projects with newly contracted GFA of 1,925,568 sq. m..

As of 30 September 2022, the Group had 268 projects under management with an aggregate GFA of 31,598,868 sq. m..

## EXPANSION OUTSIDE HENAN

For the nine months ended 30 September 2022, the Group had one newly contracted project in provinces other than Henan, with newly contracted GFA of 67,100 sq. m..

As of 30 September 2022, the Group had 24 projects under management in provinces other than Henan with an aggregate GFA of 2,582,442 sq. m., accounting for 8.2% of the total GFA of the Group's projects under management. These projects cover six provinces or autonomous region outside Henan, including Anhui, Shanxi, Shaanxi, Hebei, Xinjiang and Hainan.

## CONTRACTED SALES OF PROJECTS UNDER MANAGEMENT

In September 2022, the contracted sales for projects under the Group's management reached RMB1,822 million, with a contracted sales GFA of 291,881 sq. m.. The average selling price per sq. m. for September 2022 amounted to RMB6,244.

For the nine months ended 30 September 2022, contracted sales for projects under the Group's management reached RMB16,039 million, representing a year-on-year decline of 36.8%, and contracted sales of GFA of 2,629,005 sq. m., representing a year-on-year decline of 36.3%. For the nine months ended 30 September 2022, the average selling price per sq. m. was RMB6,101, representing a year-on-year decline of 0.7%.
