UNAUDITED OPERATING DATA FOR THE NINE MONTHS ENDED 30 SEPTEMBER 2022

The board of directors (the “**Board**”) of Sinic Holdings (Group) Company Limited (the “**Company**”) is pleased to announce that the contracted sales amount of the Company and its subsidiaries (the “**Group**”), together with its joint ventures and associates, for the nine months ended 30 September 2022 was approximately RMB2,716 million, of which approximately RMB246 million was recorded in September 2022. From January to September 2022, the contracted sales area was approximately 272,017 sq.m., with an average selling price of RMB9,969 per sq.m..

The preliminary data disclosed above is unaudited and is based on the summary of management information of the Group and its joint ventures and associates, which may differ from the data to be disclosed in the audited or unaudited financial statements to be published by the Company on yearly or half-yearly basis or are subject to changes due to various uncertainties during the process of collection and collating of such preliminary data.
