EXTENSION OF THE TIME LIMIT FOR THE COMPLETION OF THE DUE DILIGENCE INVESTIGATION IN RELATION TO SUBSCRIPTION OF 30% OF THE ENLARGED REGISTERED CAPITAL OF HUBEI KANG SHI ZHEN YI YAO TECHNOLOGY CO., LTD.*

Reference is made to the announcements of Smart Globe Holdings Limited (the “**Company**”) dated 15 July 2022 and 15 August 2022 in relation to the subscription of 30% of the enlarged registered capital of Hubei Kang Shi Zhen Yi Yao Technology Co., Ltd.* by the Company (the “**Announcements**”). Unless the context otherwise requires, capitalised terms in this announcement shall have the same meanings as defined in the Announcements.

EXTENSION OF TIME LIMIT FOR THE COMPLETION OF THE DUE DILIGENCE INVESTIGATION

As additional time is required for the Company, being the Subscriber, to complete its due diligence investigation on the business, financial, legal and all other aspects of the Target Company (“**Due Diligence Investigation**”), on 12 October 2022, the Company and the Target Company entered into a supplemental agreement, pursuant to which the parties thereunder mutually agreed that the time limit for the completion of the Due Diligence Investigation as stipulated in the Agreement shall be extended for 45 days to 135 days after the date of signing the Agreement.

Save as the extension of the time limit for the completion of the Due Diligence Investigation, all other terms and conditions of the Agreement and the Supplemental Deed remain unchanged and in full force and effect in all respects.

As the Completion is subject to the fulfilment of a number of conditions, the Subscription may or may not proceed to Completion. Shareholders and potential investors of the Company are reminded to exercise caution when dealing in the Shares or other securities of the Company.
