The board of directors (the “**Board**”) of Radiance Holdings (Group) Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) hereby announces that for September 2022, the contracted sales of the Group, together with its joint ventures and associates, amounted to approximately RMB3.31 billion, the contracted gross floor area sold was approximately 227,000 square meters.

For the nine months ended 30 September 2022, the aggregated contracted sales of the Group, together with its joint ventures and associates, amounted to approximately RMB35.36 billion, the aggregated contracted gross floor area sold was approximately 2,371,000 square meters and the contracted average selling price amounted to approximately RMB14,900 per square meter.
