VOLUNTARY ANNOUNCEMENT UNAUDITED THIRD QUARTERLY RESULTS FOR THE NINE MONTHS ENDED 30 SEPTEMBER 2022

This announcement is made by the Company and its subsidiaries (the "Group") on a voluntary basis.

The board (the "Board") of directors (the "Directors") of the Company announces the unaudited revenue and gross profit of the Group for the nine months ended 30 September 2022 ("9M2022"), together with the comparative figures for the nine months ended 30 September 2021 ("9M2021"), as follows:

Despite the regional control and restrictive measures imposed in various cities in the People's Republic of China from time to time, the Group recorded continuous growth in its operational and financial performance for 9M2022, as compared to the corresponding period in 2021.

The Group recorded revenue of approximately HK\$2,195.1 million for 9M2022 (9M2021: HK\$1,726.9 million), representing an increase of approximately 27.1% as compared to 9M2021. Gross profit amounted to approximately HK\$403.0 million for 9M2022 (9M2021: HK\$347.4 million), representing an increase of 16.0% as compared to 9M2021.

The increase in revenue and gross profit are mainly attributable to the following reasons:

- (a) the revenue and gross profit contributed by Allport Cruise Logistics Inc. and its subsidiaries which were acquired by the Group in March 2022;
- (b) the revenue and gross profit contributed by CN Logistics Vietnam Co. Limited since its establishment in May 2022; and
- (c) the significant growth in revenue and gross profit from offices located in Italy and the Southeast Asia following the expansion of the Group's customer base.

SEGMENTAL ANALYSIS

The Group is principally engaged in the provision of air freight and ocean freight forwarding services, and the provision of distribution and logistics services. Below are the unaudited segment results of the Group for 9M2022, together with the comparative figures for 9M2021:
