On 1 September 2022, the Company as issuer entered into Subscription Agreements with 38 General Mandate Subscribers, Mr. Shi Banchao and 2 Connected Subscribers, pursuant to which the Company has conditionally agreed to issue, and the General Mandate Subscribers, Mr. Shi Banchao and the Connected Subscribers have conditionally agreed to subscribe for 31,575,598, 32,000,000 and 5,750,000 Subscription Shares at the Subscription Price of HK\$1.045 per Share, respectively. The above-mentioned Subscription is subject to conditions and may or may not be proceeded. Please refer to the Company's announcements dated 1 September 2022, 23 September 2022 and 24 October 2022, and circular dated 1 October 2022 for details.

On 17 October 2022, the completion of the General Mandate Subscription by 37 General Mandate Subscribers took place in accordance with the terms and conditions of the relevant Subscription Agreements. An aggregate of 30,931,598 General Mandate Subscription Shares have been issued and allotted to 37 General Mandate Subscribers at the Subscription Price of HK\$1.045 per Share. The subscription of 644,000 General Mandate Subscription Shares had not proceed to completion and was terminated as mutually agreed by the Company and the relevant General Mandate Subscribers. As at the end of October 2022, the Company has not issued or allotted shares to Mr. Shi Banchao and 2 Connected Subscribers.
