POLL RESULTS OF THE EXTRAORDINARY GENERAL MEETING HELD ON 9 NOVEMBER 2022

The Resolution as set out in the EGM Notice was duly passed on a poll at the EGM.

Reference is made to the notice (the “**EGM Notice**”) of the extraordinary general meeting (the “**EGM**”) of Overseas Chinese Town (Asia) Holdings Limited (the “**Company**”) and the circular of the Company (the “**Circular**”), both dated 25 October 2022. Unless otherwise defined, capitalised terms used in this announcement shall have the same meanings as defined in the Circular.

At the EGM held at 3/F., Jacaranda IBC, OCT Harbour, Baishi Road, Nanshan District, Shenzhen, the PRC on 9 November 2022, poll voting was adopted for the resolution set out in the EGM Notice (the “**Resolution**”) as required by the Listing Rules. The Resolution was approved by the Shareholders at the EGM, and the poll results in respect of the Resolution are as follows:

As more than half of the votes (including proxies) were cast in favour of the above Resolution, the Resolution was passed as an ordinary resolution of the Company.

- (b) The total number of Shares in issue as at the date of the EGM: 748,366,000 Shares, being the total number of Shares entitling the holders to attend and vote on the Resolution at the EGM.
- (c) There were no restrictions on the Shareholders to cast any votes on the Resolution at the EGM. There were no Shares entitling the holders to attend and abstain from voting in favour at the EGM as set out in Rule 13.40 of the Listing Rules. No Shareholders were required to abstain from voting on the Resolution at the EGM. No Shareholders had stated their intention in the Circular to vote against or to abstain from voting on the Resolution at the EGM.

Computershare Hong Kong Investor Services Limited, the Company's Hong Kong branch share registrar, acted as the scrutineer for the vote taking at the EGM.

Except for Mr. Zhang Dafan and Mr. Chu Wing Yiu who were unable to attend the EGM due to other engagements, all Directors attended the EGM, either in person or through electronic means.
