- 5. This form of proxy must be signed by you or your attorney duly authorised in writing or, in the case of a corporation, must be executed either under its common seal or under the hand of an officer or attorney duly authorised.

In the case of joint holders of a Share, the vote of the person, whether attending in person or by proxy or participate through the online platform, whose name stands first on the Register of Members of the Company in respect of such Share shall be accepted to the exclusion of the vote(s) of the other joint holder(s).

To be valid, this form of proxy, together with the power of attorney or other authority, if any, under which it is signed or a notarially certified true copy thereof, must be deposited at the Company's branch share registrar and transfer office in Hong Kong, Computershare Hong Kong Investor Services Limited at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong, not less than forty-eight (48) hours before the time appointed for holding the SGM or at any adjournment thereof.
- 8. Completion and delivery of this form of proxy shall not preclude you from attending and voting either in person or online at the SGM (and at any adjournment thereof) if you so wish.
- 9. ANY ALTERATION MADE TO THIS FORM OF PROXY MUST BE INITIALLED BY THE PERSON WHO SIGNS IT.
- 10. The full text of the resolution is set out in the SGM Notice. Unless otherwise stated, capitalised terms used above shall have the same meanings as defined in the SGM Notice.
