WON THE GUANGDONG SPORTS LOTTERY TERMINALS SUPPLY CONTRACT

The board of directors (the “Board”) of China Ecotourism Group Limited (the “Company”, together with its subsidiaries, collectively referred to as the “Group”) is pleased to announce that Guangzhou Lottnal Terminal Company Limited (“Guangzhou Lottnal Company”), a subsidiary of the Company, has recently succeeded in winning the bid for the Guangdong Sports Lottery Issuance Centre Terminals Procurement Project, providing 2,200 lottery sales terminals for the Guangdong Sports Lottery Issuance Centre (“Guangdong Sports Lottery”).

Guangdong Province is the province with the largest lottery sales in the country. In 2021, the sales of lottery tickets reached RMB37.9 billion, accounting for more than 10% of the country’s total lottery sales. From January to September 2022, the sale of lottery tickets amounted to RMB30.6 billion, an increase of 10.5% over the same period of last year. The public welfare fund raised is also growing, and it has made positive contributions to improving people’s livelihood and promoting the development of sports.

The KT301-T4-01 terminal provided by Guangzhou Lottnal Company for Guangdong Sports Lottery has advanced configuration and high processing performance. It is one of the lottery ticket readers with the fastest ticket reading speed and the widest format in China, with the characteristics of high reliability, low power consumption, easy to use and less maintenance required.

Before winning the bid for the Guangdong Sports Lottery Terminal Procurement Project, Guangzhou Lottnal Company also successfully won the bid for the Guangdong Welfare Lottery Sales Terminals Procurement Project in March this year. At the same time, another subsidiary of the Group also obtained a technical service contract for the Guangdong Computer Welfare Lottery Sales Management System in March this year.

Being able to continue to provide multifaceted services such as terminal equipment and technical systems for the largest provincial market in China is the full affirmation of the lottery organization for the Group's years of hard work in the lottery industry. In recent years, the lottery industry has entered into a more stable and healthy development path, and so the future development is promising. The Group will continue to maintain its leading position in the industry and provide assistance for the transformation and high-quality development of lottery organization.
