**UNAUDITED THIRD QUARTERLY RESULTS OF A SUBSIDIARY
CHINA NETCOM TECHNOLOGY HOLDINGS LIMITED
FOR THE NINE MONTHS ENDED 30 SEPTEMBER 2022**

This announcement is made pursuant to Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

The board (the “**Board**”) of directors (the “**Directors**”) of 51 Credit Card Inc. (the “**Company**”) refers to the announcement dated 9 November 2022 (the “**China Netcom Results Announcement**”) issued by China Netcom Technology Holdings Limited (“**China Netcom**”), a subsidiary of the Company whose shares are listed and traded on GEM of the Stock Exchange (stock code: 8071), in relation to the unaudited third quarterly results of China Netcom and its subsidiaries (collectively, the “**China Netcom Group**”) for the nine months ended 30 September 2022.

In the China Netcom Results Announcement, the unaudited results of the China Netcom Group for the nine months ended 30 September 2022 were reported as follows:

- Consolidated revenue from continuing operations of the China Netcom Group of approximately HK\$16,241,000 (nine months ended 30 September 2021: approximately HK\$29,726,000)
- Consolidated loss from continuing and discontinued operations attributable to owners of China Netcom of approximately HK\$7,768,000 (nine months ended 30 September 2021: approximately HK\$14,474,000)
- Basic and diluted loss per share from continuing and discontinued operations of China Netcom of approximately HK0.17 cents (nine months ended 30 September 2021: approximately HK0.31 cents)
