Announcement Trading Update Power Generation For October 2022

This announcement is made by CGN New Energy Holdings Co., Ltd. (the "Company") on a voluntary basis.

The board (the "Board") of directors (the "Directors") of the Company announces that, according to the preliminary statistics of the Company, the power generation of the Company and its subsidiaries (the "Group") on a consolidated basis amounted to 1,576.0GWh for the month of October 2022, representing an increase of 5.3% compared with the corresponding period of 2021. In particular, power generation of PRC wind projects increased by 17.0%, power generation of PRC solar projects increased by 12.0%, power generation of PRC cogen and gas-fired projects decreased by 17.1%, power generation of PRC hydro projects decreased by 49.3% and power generation of Korea projects decreased by 5.0%. For the ten months ended 31 October 2022, the accumulated power generation of the Group of this year amounted to 15,745.2GWh, representing an increase of 4.4% compared with the corresponding period of 2021. In particular, power generation of PRC wind projects increased by 23.5%, power generation of PRC solar projects increased by 6.1%, power generation of PRC cogen and gas-fired projects decreased by 12.3%, power generation of PRC hydro projects decreased by 32.4% and power generation of Korea projects decreased by 9.8%.
