### **POSITIVE PROFIT ALERT**

This announcement is made by Ching Lee Holdings Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders and potential investors of the Company that, based on the preliminary review of the unaudited consolidated management accounts of the Group for the six months ended 30 September 2022, the Group is expected to record the net profit for the six months ended 30 September 2022 between HK\$1.3 million and HK\$1.7 million, as compared to the net loss of the Group for the six months ended 30 September 2021 of approximately HK\$9.3 million. The Board considers that the profit of the Group was mainly attributable to the project cost control enhancement and cost saving in administrative and operating expenses for the six months ended 30 September 2022.

The Company is still in the course of finalizing its consolidated financial results of the Group for the six months ended 30 September 2022. The information contained in this announcement is only based on the preliminary assessment made by the Board with reference to the information currently available, which has not been reviewed nor audited by the external auditor or audit committee of the Company and may be subject to change. Shareholders and potential investors are advised to read carefully the interim results announcement of the Group for the six months ended 30 September 2022 when it is published.
