For holders of domestic shares of the Bank who wish to attend the EGM or any adjournment thereof, this form of proxy (together with a notarially certified copy of the power of attorney or other authority (if any) if this form of proxy is signed by a person on behalf of the appointor) must be returned to the Bank's Board Office at No. 888 Shangjiang Street, Daoli District, Harbin 150010, Heilongjiang Province, China not less than 24 hours before the time stipulated for convening the EGM or any adjournment thereof. The above documents must be delivered by the holder of H Shares of the Bank to the Bank's H Share Registrar, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not less than 24 hours before the time stipulated for convening the EGM or any adjournment thereof.
- 7. Completion and delivery of this proxy form will not preclude you from attending and voting at the EGM if you so wish.
