**QUARTERLY UPDATE ON PROGRESS OF RESUMPTION AND
CONTINUED SUSPENSION OF TRADING**

This announcement is made by Silk Road Logistics Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rules 13.09 and 13.24A of the Listing Rules.

References are made to the announcements of the Company dated (1) 24 May 2022 in respect of (i) the Listing Review Committee’s decision to uphold the decision of the Listing Committee to suspend the trading in the Company’s shares and (ii) the suspension of trading in the shares of the Company with effect from 24 May 2022; (2) 7 June 2022 in relation to, among other things, the Resumption Guidance; and (3) 23 August 2022 regarding the quarterly update on the progress of resumption (collectively, the “**Announcements**”). Unless otherwise specified, capitalised terms used in this announcement shall have the same meanings as those defined in the Announcements.

QUARTERLY UPDATE ON PROGRESS OF RESUMPTION AND BUSINESS OPERATIONS

The Board wishes to inform the Company's shareholders and potential investors of the progress of actions recently taken by the Company to fulfil the Resumption Guidance, including the latest development of the Group's business operations.

Since the publication of the Announcements, the Company has been communicating with professional advisers of the Group and various potential business partners to explore and consider different options and future opportunities in order to prepare a viable resumption proposal to resolve the issues leading to the trading suspension and address the Resumption Guidance, and to work on the resumption of the trading in the shares of the Company as soon as possible.

The Company is principally engaged in the Commodities Trading Business, the Logistics Business and the Oil Business. Apart from carrying out its existing businesses and projects, over the past few months the Company has been identifying potential opportunities including but not limited to supply of construction raw materials. To cater for future business opportunities, the Group has set up subsidiaries in Tianjin which will carry out construction raw materials trading and commodity trading in China. The Board is of the view that if any potential project is identified, it will be beneficial to the development of the Group's businesses and will further strengthen the demonstration by the Group of its compliance with Rule 13.24 of the Listing Rules.

As at the date of this announcement, no definitive agreement in relation to any potential project which constitutes a notifiable transaction has been entered into by the Company, and the aforesaid strategies may or may not lead to any notifiable transactions, and there is no certainty that any definitive agreement will be reached. The Company will publish further announcement(s) in accordance with the Listing Rules to inform the Shareholders of material updates as and when appropriate.

References are also made to the announcements of the Company dated 23 July 2020, 5 August 2021, 25 August 2021 and 10 October 2022 in relation to the civil complaint against 絲路物流(遷安)有限公司 (transliterated as Silk Road Logistics (Qian'an) Company Limited, “**Qian'an Logistics**”), an indirect non wholly-owned subsidiary of the Company. Following the dismissal of the appeal filed by the claimant and the upholding of the judgment of the Shanghai Financial Court in respect of the said civil complaint, the Group has resumed its negotiation with the minority shareholder of Qian'an Logistics to restart the commodity trading and warehousing business of Qian'an Logistics.

CONTINUED SUSPENSION OF TRADING

At the request of the Company, trading in the shares of the Company on the Stock Exchange has been suspended with effect from 9:00 a.m. on Tuesday, 24 May 2022. Pending fulfilment of the Resumption Guidance, trading in the shares of the Company on the Stock Exchange will remain suspended until further notice.

Shareholders and potential investors should exercise caution when dealing in the Shares of the Company.
