In order to facilitate the JPLs in discharging their duties and performing their role to gather information and investigate into the affairs of the Company, the Petitioner applied to the Bermuda Court to expand the powers of the JPLs by filing the JPLs Powers Summons.

Trading in the Shares on the Stock Exchange has been suspended with effect from 9:00 a.m. on 1 April 2022 and will remain suspended until further notice.
