UNAUDITED OPERATING FIGURES FOR OCTOBER 2022

The board of directors (the “**Board**”) of Sanxun Holdings Group Limited (the “**Company**”) wishes to provide the shareholders of the Company and potential investors with a sales update containing certain operating data of the Group for the ten months ended 31 October 2022. For the ten months ended 31 October 2022, the aggregate contracted sales of the Company, its subsidiaries and associated companies (the “**Group**”) was approximately RMB2,007 million, the aggregate contracted gross floor area was 264,367 sq.m. and the average selling price was approximately RMB7,591.8 per sq.m..
