VOLUNTARY ANNOUNCEMENT LITIGATION PROCEEDINGS COMMENCED BY SUBSIDIARIES

The board of directors (the "Board") of AAC Technologies Holdings Inc. (the "Company", together with its subsidiaries, the "Group") hereby announces that the subsidiaries of the Company, namely AAC Optics (Changzhou) Co., Ltd.* (誠瑞光學(常州)股份有限公司)("AAC Optics") and AAC Raytech Optics (Changzhou) Co., Ltd.* (瑞泰光學(常州)有限公司)("Raytech Optics"), commenced 10 intellectual property patent-related litigation proceedings (the "Litigation Proceedings") against the following companies (collectively, the "Defendant Companies") for infringement of certain intellectual property rights owned by the Group in the People's Republic of China ("PRC"):

- (1) Zhejiang Sunny Optics Co., Ltd.* (浙江舜宇光學有限公司);
- (2) Lezhitian Communication Equipment Business Department of Jiangning District, Nanjing City * (南京市江寧區樂之田通訊器材經營部);
- (3) Nanjing Wenxuan Electronic Technology Co., Ltd.* (南京文軒電子科技有限公司);
- (4) Nanjing Juxiangwei Information Technology Co., Ltd.* (南京聚象維信息科技有限公司); and
- (5) Nanjing Yuexing Electronic Technology Co., Ltd.* (南京越星電子科技有限公司).

The Group owns more than 2,300 invention patents in relation to optics lens and more than 400 utility model patents in relation to optics lens in the PRC and the world. In the relevant claims of the Litigation Proceedings, AAC Optics and Raytech Optics are claiming that the Defendant Companies have infringed their invention patents and are seeking the following reliefs against the relevant Defendant Companies:

- (1) an order to immediately cease infringement of the Group's invention patents, including ceasing production, offer for sale, sale of products which infringe the invention patents;
- (2) an order to destroy the inventory of products which infringed the invention patents and the specific moulds for manufacturing of such products which infringe the Group's invention patents;
- (3) a compensation order for economic losses;
- (4) a compensation order in favour of AAC Optics and Raytech Optics for reasonable and related costs incurred in stopping the infringement activities; and
- (5) an order to bear the costs of the related Litigation Proceedings.

The Litigation Proceedings have been officially accepted by Nanjing Intermediate People's Court* (江蘇省南京市中級人民法院), Jiangsu Province, PRC on 22 November 2022 and 23 November 2022.

The Company will make further announcement(s) in relation to the Litigation Proceedings as and when appropriate pursuant to the relevant requirements of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.
