Remarks: Pursuant to the special resolution passed at the special general meeting of the Company held on 28 November 2022, the Company implemented a share consolidation of every ten (10) issued existing shares of par value of HK\$0.1 each in the issued share capital of the Company into one (1) issued consolidated share of par value of HK\$1.00 each with effect from 30 November 2022. Immediately following the share consolidation, the issued share capital of the Company of HK\$366,186,472.9 divided into 3,661,864,729 consolidated shares be reduced to HK\$3,661,864.72 divided into 366,186,472 new shares by cancelling the paid-up capital of the Company to the extent of HK\$0.99 on each of the then issued consolidated share, such that the par value of each of the issued consolidated share be reduced from HK\$1.00 to HK\$0.01. Details of which are set out in the Company's circular dated 3 November 2022.

We hereby confirm to the best knowledge, information and belief that, in relation to each issue of securities as set out in Section I, it has been duly authorised by the board of directors of the listed issuer and, insofar as applicable:

10. *“Identical” means in this context:*

- *the securities are of the same nominal value with the same amount called up or paid up;*
- *they are entitled to dividend/interest at the same rate and for the same period, so that at the next ensuing distribution, the dividend/interest payable per unit will amount to exactly the same sum (gross and net); and*
- *they carry the same rights as to unrestricted transfer, attendance and voting at meetings and rank pari passu in all other respects.*
