The 3% guaranteed convertible bonds due 2025 in an aggregate principal amount of US\$175,000,000 (the "Convertible Bonds") were issued in 2019.

On 5 December 2022, PB Issuer (No.5) Limited (stock code: 40097), being the issuer, repurchased US\$2,750,000 of the Convertible Bonds from its existing bondholders (the "Repurchased Convertible Bonds"), representing 13,220,414 shares if the Repurchased Convertible Bonds are fully converted into shares at the conversion price of HK\$1.63 per share. None of the Repurchased Convertible Bonds were converted into actual shares. Upon completion of the repurchase, the principal amount of the outstanding Convertible Bonds was US\$52,510,000.
