### POSITIVE PROFIT ALERT

This announcement is made by Prosper One International Holdings Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “**Directors**” and the “**Board**”, respectively) wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on the Board’s preliminary review of the unaudited consolidated financial statements of the Group for the six months ended 31 October 2022 and other information currently available, the Group expects to record a profit attributable to owners of the Company of approximately HK\$3.6 million for the six months ended 31 October 2022 as compared to the loss attributable to owners of the Company of approximately HK\$3.2 million for the six months ended 31 October 2021. The expected profit was primarily attributable to the combined effect of (i) the decrease in core operating expenses of the Group’s watches retail business in Hong Kong as a result of downsizing the retail network by closing underperforming shops; (ii) the decrease in non-cash expenses such as depreciation of right-of-use assets and depreciation of property, plant and equipment; and (iii) the increase in gross profit of the Group’s trading business, which offset the decline in the gross profit of the Group’s watches retail business.

The Company is still in the process of finalising the interim consolidated financial results of the Group for the six months ended 31 October 2022. The information contained in this announcement is only based on the Board’s preliminary review of the unaudited consolidated financial statements of the Group for the six months ended 31 October 2022 and other information currently available, which have not been audited or reviewed by the independent auditor or the audit committee of the Company and

may be subject to adjustments. Shareholders and potential investors should read carefully the interim results announcement of the Company for the six months ended 31 October 2022, which will be published on 30 December 2022.
