UNAUDITED OPERATING FIGURES FOR NOVEMBER 2022

The board of directors (the “**Board**”) of Sanxun Holdings Group Limited (the “**Company**”) wishes to provide the shareholders of the Company and potential investors with a sales update containing certain operating data of the Group for the eleven months ended 30 November 2022. For the eleven months ended 30 November 2022, the aggregate contracted sales of the Company, its subsidiaries and associated companies (the “**Group**”) was approximately RMB2,109 million, the aggregate contracted gross floor area was 278,622 sq.m. and the average selling price was approximately RMB7,569.7 per sq.m..

The above-mentioned operating figures are unaudited and are based on preliminary internal information of the Group, which may differ from the figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Group on an annual or half-yearly basis due to various uncertainties during the process of collecting such information.
