- 7. This form of proxy must be signed by you or your attorney duly authorized in writing or, in the case of a corporation, must be either executed under its seal or under the hand of an officer, attorney or other person duly authorized to sign the same.
- 8. In the case of joint holders of any shares, any one of such joint holders may vote at the Meeting by proxy, in respect of such shares as if he were solely entitled thereto. However, if more than one of such joint holders is present at the Meeting, either virtually or by proxy, the vote of the joint holder whose name stands first in the Register of Members and who tenders a vote by proxy, will be accepted to the exclusion of the votes of the other joint holder(s).
- 9. On a poll, every shareholder present by electronic means or by proxy shall be entitled to one vote for each share registered in his name. The result of such poll shall be deemed to be the resolution of the Meeting at which the poll was so taken.

10. Completion and delivery of this form of proxy will not preclude you from attending and voting by proxy at the Meeting if you so wish. In such event, the instrument appointing a proxy shall be deemed to be revoked.
