In addition, the SPAC warrants and promoter warrants of the Company will expire worthless if any of the following events occurs: (a) we fail to obtain the requisite approvals in respect of the continuation of our Company following a Material Change Event; or (b) we fail to make an announcement of the terms of a De-SPAC Transaction within 24 months from the Listing Date (or such other extension period approved by the Shareholders and the Stock Exchange), or complete the De-SPAC Transaction within 36 months from the Listing Date (or such other extension period approved by the Shareholders and the Stock Exchange).
The above number of new shares which maybe issued is based on the maximum number of shares to be issued upon the exercise of one warrant on a cashless basis, which is one-half of one share.
