UNAUDITED OPERATING STATISTICS
FOR THE YEAR ENDED 31 DECEMBER 2022

The board of directors (the “**Board**”) of Shimao Group Holdings Limited (the “**Company**”) hereby announces certain unaudited operating statistics of the Company and its subsidiaries (together the “**Group**”) for the year ended 31 December 2022 as follows:

- The Group’s aggregated contracted sales for the year ended 31 December 2022 amounted to approximately RMB86.52 billion and the Group’s aggregated contracted sold area amounted to 5,373,875 sq.m.. The average selling price for the year ended 31 December 2022 was RMB16,101 per sq.m..
- In December 2022, the Group’s contracted sales amounted to approximately RMB7.03 billion and the Group’s contracted sold area amounted to 446,082 sq.m.. The average selling price for December 2022 was RMB15,757 per sq.m..

The above-mentioned sales data is unaudited and is based on preliminary internal information of the Group, which may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such sales information.
