## **SUCCESSFULLY WON THE GANSU SPORTS LOTTERY TERMINALS PROCUREMENT PROJECT**

Such terminal has won several bids in terminal procurement projects, which reflects the industry organization’s recognition of the ability, quality and value towards Guangzhou Lottnal Company for its years of deep cultivation within the industry.

Recently, the China Sports Lottery Administration Centre under the General Administration of Sport issued two announcements involving lotto and digital sports lotteries within 6 days. Starting from 1 January 2023, the sales time of lotto and digital sports lotteries was extended and the maximum number of betting periods for multi-phase was adjusted from 15 betting to 20 betting. These adjustments will bring lottery buyers with more sufficient and convenient lottery shopping experience.
