Cancellation of listing

The Stock Exchange of Hong Kong Limited (the **Exchange**) announced that with effect from 9:00 am on 12 January 2023, the listing of the shares of Next Digital Limited (In Liquidation) (the **Company**) will be cancelled under Rule 6.01A(1).

The Exchange announces that the listing of the Company's shares will be cancelled with effect from 9:00 am on 12 January 2023 under Rule 6.01A(1).

Trading in the Company's shares has been suspended since 17 June 2021. Under Rule 6.01A(1), the Exchange may delist the Company if trading does not resume by 16 December 2022.

The Company failed to fulfill the resumption guidance set by the Exchange and resume trading in its shares by 16 December 2022. On 23 December 2022, the Listing Committee decided to cancel the listing of the Company's shares on the Exchange under Rule 6.01A(1).

The Exchange has requested the Company to publish an announcement on the cancellation of its listing.

The Exchange advises shareholders of the Company who have any queries about the implications of the delisting to obtain appropriate professional advice.
