VOLUNTARY ANNOUNCEMENT BUSINESS UPDATE

This is a voluntary announcement made by CENTRAL CHINA MANAGEMENT COMPANY LIMITED (the “**Company**”) to provide its Shareholders and potential investors of the Company with information in relation to the latest developments regarding the Company.

The Board is pleased to announce that, on 10 January 2023, the Company has successfully held the Centralized Signing Ceremony cum the Partner Appreciation Event at Unique Henan Land of Dramas (《只有河南•戲劇幻城》) in Zhengzhou City, Henan Province. During this event, the Group signed 27 projects in total with a total estimated contracted gross floor area (“**GFA**”) of 3,544,300 square metres (“**sq.m.**”).

Among these 27 projects, there are 24 projects under framework agreements with a total estimated contracted GFA of 3,303,400 sq.m., among which 6 projects are government project management projects with a total estimated contracted GFA of 1,524,800 sq.m., representing 43% of the total estimated contracted GFA of contracted projects, and 3 projects are conducted in provinces other than Henan Province with a total estimated contracted GFA of 291,200 sq.m.. The 3 remaining ones are projects under formal project management agreements with a total estimated contracted GFA of 240,900 sq.m., all of which are commercial project management projects in Henan Province.

The Board believes that this Centralized Signing Ceremony can further deepen the cooperation between the Group and partners to facilitate the further implementation of the Group’s development strategy for its project management business and to bring more opportunities for the Group’s business development.

The Board wishes to emphasize that the execution of cooperation and transaction contemplated under framework agreements is subject to specific agreements signed, and such cooperation may or may not proceed. Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
