On January 26, 2022, the Company issued and allotted additional 10,787,400 shares at an offering price of HKD43.60 per share by way of public offering pursuant to the over-allotment option as disclosed in the Company's announcement dated January 21, 2022. Net proceeds received amounted to approximately HKD452.66 million after deduction of the underwriting fees and commissions and estimated expenses payable by the Company in connection with its global offering. As at the date of this announcement, the Group has utilized the net proceeds for the purposes as set out in the section headed "Use of Net Proceeds from Global Offering" in the Company's interim report dated September 26, 2022.

Save as disclosed above, Company has not conducted any equity fund raising activities in the past twelve-month period immediately preceding the date of this announcement.

#### REASONS FOR THE PLACING AND SUBSCRIPTION AND USE OF PROCEEDS

The Group is principally engaged in researching, developing, manufacturing, testing, sales and after-sale services for power tools, outdoor power equipment and related products.
