Reference is made to the Company's announcement on January 13, 2023 regarding the conversion of 100,107,425 Domestic Shares and 74,509,781 Unlisted Foreign Shares into H Shares was completed on January 13, 2023. The converted H Shares were allotted on January 13, 2023 and listed on January 16, 2023 at 9:00 a.m..

9. *Items (i) to (viii) are suggested forms of confirmation which may be amended to meet individual cases.*

10. *“Identical” means in this context:*

- *the securities are of the same nominal value with the same amount called up or paid up;*
- *they are entitled to dividend/interest at the same rate and for the same period, so that at the next ensuing distribution, the dividend/interest payable per unit will amount to exactly the same sum (gross and net); and*
- *they carry the same rights as to unrestricted transfer, attendance and voting at meetings and rank pari passu in all other respects.*
