CHANGE OF COMPANY NAME AND STOCK SHORT NAME

References are made to:

- (i) the announcement of Inspur Digital Enterprise Technology Limited (formerly known as Inspur International Limited) (the “**Company**”) dated 10 November 2022;
- (ii) the circular of the Company dated 22 November 2022 (the “**Circular**”) in relation to the Company’s extraordinary general meeting held on 14 December 2022 (the “**EGM**”); and
- (iii) the announcement of the Company dated 14 December 2022 on the EGM poll results,

in connection with the Proposed Change of Company Name.

Unless the context otherwise requires, capitalised terms used in this announcement shall have the same meanings as those defined in the Circular.

CHANGE OF COMPANY NAME

The Board is pleased to announce that the proposed change of the English name of the Company from “Inspur International Limited” to “Inspur Digital Enterprise Technology Limited” and its dual foreign name in Chinese from “浪潮國際有限公司” to “浪潮數字企業技術有限公司” have become effective from 22 December 2022 pursuant to the Certificate of Incorporation on Change of Name issued by the Registrar.

The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 27 January 2023 confirming the registration of the new names of the Company in Hong Kong under Part XVI of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

CHANGE OF STOCK SHORT NAME

The stock short name of the Company for trading in the Shares on the Stock Exchange will be changed from “INSPUR INT’L” to “INSPUR DIGI ENT” in English and from “浪潮國際” to “浪潮數字企業” in Chinese with effect from 9:00 a.m. on 14 February 2023.

The stock code of the Company on the Stock Exchange remains unchanged as “596”. Furthermore, the website and the logo of the Company remain unchanged.

EFFECTS OF THE CHANGE OF COMPANY NAME

The change in the name of the Company and the corresponding changes thereto such as the change of the Company’s stock short name will not affect any right of the Shareholders or the Company’s daily business operation and its financial position.

All existing share certificates in issue bearing the Company’s former name shall continue to be evidence of legal title to the shares of the Company and be valid for trading, settlement, registration and delivery purposes. Accordingly, there will not be any arrangement for free exchange of existing share certificates for new share certificates bearing the new names of the Company.

New share certificates bearing the Company’s new names will be issued with effect from 14 February 2023.
