### **POSITIVE PROFIT ALERT**

This announcement is made by Theme International Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) wishes to inform the shareholders of the Company and potential investors that, based on the preliminary review of the management accounts of the Group for the twelve months ended 31 December 2022 (the “**Relevant Year**”) and the information currently available to the Board, the Group expected to record an increase in net profit for the Relevant Year by approximately HK\$260 million, which represented an increase of approximately 22% as compared to the year ended 31 December 2021 (the “**Corresponding Year**”), to approximately HK\$1.46 billion (net profit for the Corresponding Year: approximately HK\$1.20 billion). The net profit attributable to owners of the Company for the Relevant Year was approximately HK\$1.10 billion (net profit attributable to owners of the Company for the Corresponding Year: approximately HK\$998 million). The increase in net profit for the Relevant Year was primarily attributable to the stable development of the Group’s existing businesses.

The information contained in this announcement is based only on the preliminary assessment by the Board upon its review of the unaudited management accounts of the Group for the twelve months ended 31 December 2022 and other information currently available to the Company which has not been reviewed or audited by the Company’s independent auditor. The annual results of the Group may be subject to adjustments following further review by the Board and the audit committee of the Company. Shareholders of the Company and potential investors are advised to refer to the details of the Company’s annual results announcement for the twelve months ended 31 December 2022 expected to be announced by the end of March 2023.
