## **FURTHER EXTENSION OF LONG STOP DATE OF PLACING OF NEW SHARES UNDER GENERAL MANDATE**

References are made to the announcement of Elife Holdings Limited (the “**Company**”) dated 12 December 2022 (the “**Announcement**”) in relation to the placing of up to 150,537,742 Placing Shares under the General Mandate and the announcements of the Company dated 5 January 2023 and 20 January 2023 (the “**Extension Announcements**”) relating to the extension of the Long Stop Date. Unless otherwise defined, capitalised terms used herein have the same meanings as defined in the Announcement and the Extension Announcements.

### **FURTHER EXTENSION OF LONG STOP DATE**

As disclosed in the announcement of the Company dated 20 January 2023, the Long Stop Date has been extended from 30 January 2023 to 20 February 2023 (or such later date as may be agreed between the Company and the Placing Agent) pursuant to the second supplemental agreement (the “**Second Supplemental Agreement**”) to the Placing Agreement dated 20 January 2023.

As additional time is required for the Placing Agent to procure investors to subscribe for the Placing Shares, the Company and the Placing Agent entered into the third supplemental agreement to the Placing Agreement on 16 February 2023 whereby the parties agreed to further extend the Long Stop Date from 20 February 2023 to 13 March 2023 (or such later date as may be agreed between the Company and the Placing Agent).

Save and except for the aforesaid change, all the terms and conditions of the Placing Agreement (as amended and supplemented by the First Supplemental Agreement and the Second Supplemental Agreement) remain unchanged and continue in full force and effect. Shareholders and potential investors of the Company are advised to exercise caution when dealing in the Shares.
