(the “**Company**”) dated December 28, 2022, the notice of the 2023 second extraordinary general meeting (the “**EGM**”), the circular of the EGM both dated January 6, 2023 and the announcement of poll results of the EGM dated January 31, 2023, in relation to, among other things, the resolutions relating to change to the company profile and amendments to the articles of association.

CHANGE OF COMPANY NAME

The board of directors (the “**Directors**”) of the Company (the “**Board**”) is pleased to announce that Changzhou Municipal Administration for Market Regulation has completed the registration of the change of the Chinese name of the Company from “中創新航科技股份有限公司” to “中創新航科技集團股份有限公司”. The Company has received a new business license dated February 17, 2023 from Changzhou Municipal Administration for Market Regulation on February 17, 2023.

The change of company name will not affect any rights of the Shareholders. All existing share certificates in issue bearing the existing English and Chinese names of the Company will continue to be evidence of the title and be valid for trading, settlement, registration and delivery for the same number of shares in the new name of the Company. New share certificates of the Company will be issued only in the new name of the Company and the securities of the Company will be traded on The Stock Exchange of Hong Kong Limited in the new name. There will not be any arrangements for free exchange of existing share certificates for new share certificates under the new name of the Company. The Company’s Chinese and English stock abbreviation and stock code will remain unchanged.

The Company will carry out necessary registration and/or filing procedures with the Companies Registry in Hong Kong. Upon obtaining the certificate of registration of alteration of name of registered non-Hong Kong company from the Companies Registry in Hong Kong, the Company will make further announcement(s) on such registration in due course.
