- 3.2 Each of the parties acknowledges that it enters into this Supplemental Subscription Agreement 2 in consideration of the new rights and benefits to be provided to it by any other parties hereto.

4. **COUNTERPARTS**

This Supplemental Subscription Agreement 2 may be executed by the parties hereto in any number of counterparts and on separate counterparts, each of which when so executed shall be deemed an original but all of which shall constitute one and the same instrument and be binding on all parties.

5. GOVERNING LAW AND JURISDICTION

- 5.1 This Supplemental Subscription Agreement 2 is governed by and shall be construed in accordance with Hong Kong law and each party hereby submits to the non-exclusive jurisdiction of the courts of Hong Kong as regards any claim or matter arising under this Supplemental Subscription Agreement.
- 5.2 Unless expressly provided to the contrary in this Supplemental Subscription Agreement 2, a person who is not a party to this Supplemental Subscription Agreement 2 shall have no right under the Contracts (Rights of Third Parties) Ordinance (Chapter 623 of the Laws of Hong Kong) to enforce any of the terms of this Supplemental Subscription Agreement 2, and whether so provided in this Supplemental Subscription Agreement 2 or not, no consent of third party is required for the amendment to (including the waiver or compromise of any obligation), rescission of or termination of this Supplemental Subscription Agreement 2.
