If no indication, your proxy will be entitled to exercise his/her discretion or to abstain. Your proxy will also be entitled to vote at his/her discretion or to abstain on any resolution properly put to the meeting other than those referred to in the notice of the EGM. The shares abstained will be counted in the calculation of the required majority.

This Proxy Form must be signed by you or your attorney duly authorized in writing or, in the case of a corporation, must be either executed under its seal or under the hand of its director or other attorney duly authorized to sign the same. In case of joint holders, this Proxy Form must be jointly signed by the shareholder whose name stands first in the register of members of the Bank.
- 7. To be valid, for holders of H shares, this Proxy Form and, if such proxy is signed by a person on behalf of the appointer pursuant to a power of attorney or other authority, a notarially certified copy of that power of attorney or other authority must be delivered to the H share registrar of the Bank in Hong Kong, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wan Chai, Hong Kong not less than 24 hours before the time appointed for holding of the EGM (i.e. before 9:00 a.m. on Tuesday, April 11, 2023). To be valid, for holders of domestic shares, this Proxy Form and, if such proxy is signed by a person on behalf of the appointer pursuant to a power of attorney or other authority, a notarially certified copy of that power of attorney or other authority must be delivered to the Bank's registered office and principal place of business in the PRC at the Board Office, Huishang Bank Building, No. 1699 Yungu Road, Hefei, Anhui Province, the PRC, postal code: 230092 not less than 24 hours before the time appointed for holding of the EGM (i.e. before 9:00 a.m. on Tuesday, April 11, 2023).
- 8. In case of joint shareholders of the Bank, only the person whose name stands first on the register of members may attend and vote at the EGM, either in person or by proxy.
- 9. A shareholder or his/her/its proxy should produce proof of identity when attending the EGM.
- 10. Completion and return of this Proxy Form will not preclude you from attending and voting in person at the EGM or at any adjourned meeting should you so wish.
