## **FERRARI STRENGTHENS PARTNERSHIP WITH BLACKBIRD AS HONG KONG IMPORTER**

This announcement is made by CCT Fortis Holdings Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) on a voluntary basis.

The board of directors of the Company (the “**Board**”) is pleased to announce that on 10 March 2023, definitive agreements relating to the Ferrari importership have been entered into between Ferrari S.p.A (“**Ferrari**”) and Blackbird Concessionaires Limited (“**Blackbird Concessionaires**”), pursuant to which Blackbird Concessionaires has been appointed as the official importer and distributor for Ferrari vehicles and the provider of after-sales services in Hong Kong and Macau (the “**Importership Appointment**”).

Ferrari is a world famous manufacturer of high performance luxury cars. Blackbird Concessionaires of the Blackbird Automotive Group, is an indirect wholly-owned subsidiary of the Company. The Blackbird Automotive Group, led by its chairman and chief executive officer Mr. TK Mak, is an operations group of the Company, which is engaged in the automotive business.

Blackbird Concessionaires was the official Ferrari dealer in Hong Kong and Macau for over five years. The Board considers the Importership Appointment (i) reflects the recognition of Blackbird Concessionaires’ long-term commitment and investment to the Ferrari brand since its appointment as an official Ferrari dealer in 2017; (ii) strengthens the partnership between Blackbird Concessionaires and Ferrari; and (iii) represents another major milestone of the Blackbird Automotive Group in the development of its automotive business globally. This Importership Appointment represents the next level of the Blackbird Automotive Group’s dealership business of luxury cars and will further enhance the reputation and status of the Blackbird Automotive Group in the global automotive sector.

The Board also believes that this Importership Appointment will strengthen the dealership business of the Blackbird Automotive Group and will become a catalyst for future growth of income and profit of the Group.
