**FINAL REMINDER ON EARLY REDEMPTION OF THE US\$300

Reference is made to the announcements of WuXi AppTec Co., Ltd.* (無錫藥明康德新藥開發股份有限公司) (the “**Company**”) dated September 3, 2019, September 4, 2019, September 5, 2019, September 17, 2019, June 3, 2020 and June 7, 2021 (the “**Announcements**”) in relation to, among other things, the issue of the US\$300 million zero coupon convertible bonds due 2024 (the “**Bonds**”). Unless otherwise defined, capitalized terms used in this announcement shall have the same meanings as those defined in the Announcements.

In accordance with the terms and conditions of the Bonds, on February 16, 2023, the Company issued a notice through the relevant clearing systems to all Bondholders, the Trustee and the Principal Agent in connection with the early redemption of all outstanding Bonds (the “**Redemption Notice**”). A reminder notice in this regard has also been issued to all Bondholders through the relevant clearing systems on March 14, 2023 (the “**Reminder Notice**”).

The Company hereby, as a final reminder and on a voluntary basis, reminds all Bondholders of the particulars of the abovementioned early redemption, which have already been set out in the Redemption Notice and the Reminder Notice, as follows:
